#### CM.19 TAXI LICENSING

(Shortly after the commencement of this item, Councillor Shellie left the room in view of his prejudicial interest and returned after the item had been dealt with.)

Further to Minute CM. 537(a) of its 8<sup>th</sup> December 2004 meeting, the Council considered a report from the Head of Planning, Health and Environment, which submitted a revised report by Independent Transport Consultants, Halcrow Limited. The consultants had assessed whether there was significant unmet demand for hackney carriage services in the District, to enable the Council to decide future policy in respect of hackney carriage numbers.

In conjunction with these reports, Members also considered recommendations from the 16<sup>th</sup> May 2005 Environment and Economic Regeneration Policy and Scrutiny Panel (Minute CM.982) as presented by its Chairman. Copies of the Panel's recommendations and a copy of the presentation to the Panel given by a representative of Halcrow Limited were circulated at the Council meeting. The Chairman of Council also drew Members' attention to Mr R South's contribution under Public Participation (Minute CM 14 above).

Having discussed the issue in detail, Members agreed to follow a path of phased deregulation, with provision for quality control and a review of licensing conditions.

#### **DECISION:**

- 1. The report of Halcrow Group Limited regarding its Hackney Carriage Unmet Demand Survey dated 31<sup>st</sup> March, 2005 be noted.
- 2. The current limit of 83 Hackney Carriage Vehicle Licences be increased to 93 with 10 additional Licences to be issued immediately by means of a ballot, as recommended in the report, but only for vehicles which comply with wheelchair local accessibility standards.
- 3. Authority be delegated to the Licensing and Environmental Committee to determine the manner in which the ballot will be conducted and to set local standards for wheelchair accessibility.
- 4. The requirements of the Department for Transport, as contained in its letter to the Chief Executive dated 16<sup>th</sup> June

2004, be noted.

- The Head of Planning, Health and Environment be authorised, in consultation with the Head of Legal and Democratic Services, to draw up a Deregulation Plan designed to:
  - a) meet the Government's request to review the case for restricting the number of hackney carriage vehicle licences;
  - b) make public the outcome of the review;
  - c) provide a three-year phased approach to removing the numerical limits on hackney carriage licences after 1<sup>st</sup> April 2008;
  - d) balance the needs of taxi users, licence holders and new entrants to the taxi industry;
  - e) address any other related issues including vehicle safety, quality and service standards.
- 6. The Cabinet be authorised, after consultation with the Licensing and Environmental Committee, to approve the Deregulation Plan in respect of the deregulation of quantity control of hackney carriage licences.
- 7. The Council review its private hire and hackney carriage conditions.

# CM.20 POLICY AND BUDGET FRAMEWORK – MATTER WHICH REQUIRES A DECISION BY COUNCIL

# Recommendation from the Planning (Development Control) Committee 10<sup>th</sup> May 2005

Implementation of Part 8 of the Anti-Social Behaviour Act 2003 - The High Hedges Regulations

As the Committee had met after the Council's agenda had been published, an updated report was circulated at the Council meeting regarding the Committee's recommendations on Development Control Practice Note 16. This set out procedures for dealing with complaints received from householders whose properties were adversely affected by high hedges.

Council was advised of an amendment required to Appendix 1 of the practice note and the Committee's proposal to charge a fee, per complaint, for a trial period to recover processing costs. In addition, Members noted that authority was needed for officers to enter land to investigate a complaint about a high hedge.

The Council was, therefore, asked to approve revised wording as set out below.

#### **DECISION:**

1. Approval be given to a fee of £300 per application (complaint) received under the High Hedges legislation, for a period of 12 months and that this fee be reviewed on an annual basis, subject to:

The reduction of the fee to a concessionary rate of £100 for complainants in receipt of Housing Benefit or Council Tax Benefit.

- 2. Delegated authority be given to the Head of Planning, Health and Environment to determine applications received under the High Hedges legislation.
- 3. Development Control Practice Note 16 High Hedges be published and adopted, subject to an amendment to the third paragraph of Appendix 1 to state that the Arboricultural Officer will aim to visit the site and undertake an inspection of the hedge within 21 days of receipt of the file (not 14 days).
- 4. Delegated authority be given to the Head of Planning, Health and Environment to make further changes to the Practice Note upon receipt of Office of the Deputy Prime Minister guidance.
- 5. Issues relating to enforcement or potential prosecution, for failure to comply with the Hedgerow Remedial Notices, be reported to the Council's Planning (Enforcement) Committee for consideration.
- 6. Delegated authority be given to the Head of Planning, Health and Environment to authorise officers to enter land under section 74 (1) of Part 8 of the Anti-Social Behaviour Act 2003, in order to investigate high hedge complaints.

The Leader commented that, currently, the Council had no way of recognising distinguished long service to the authority and the appointment of Honorary Aldermen was an appropriate way of recognising such service.

- 2. Authorisation be given to the Cabinet, after seeking the views of Group Leaders, to consider and make recommendations to the Council on nominations to the position of Honorary Alderman.
