1. PURPOSE OF REPORT

1.1 To amend the existing strategy with recent legislative and regulatory changes which reflect the current working practices associated with delivering the contaminated land strategic objectives.

2. **RECOMMENDATION**

RECOMMENDED TO COUNCIL:

2.1 The Amended Contaminated Land Strategy (2007-2010) be adopted.

3. BACKGROUND

3.1 The document amends the existing strategy adopted in 2001 for the next 3 years. The document details various milestones in the governments programme and marries the Councils key corporate

objectives to those defined by guidance relating to site identification, risk analysis, protecting the public and joint working with other interested parties such as Planning colleagues and the Environment Agency.

- 3.2 Key areas of change identified since the Strategy's publication in 2001 are:-
 - Timescales for the implementation of the Councils targets on pages 19 and 20 have now changed.
 - Since the formal adoption of the Contaminated Land Inspection Strategy Government guidelines have been subject to change. ICRCL guidelines have been withdrawn and replaced by a set of soil guideline values for 10 different contaminants. The Council has invested in the WS Atkins Consultants soil screening values which are used where there is no SGV available for a contaminant.
 - The timescale for the Council's priority actions on pages 24 and 25 have been amended since the adoption of the original strategy in April 2001. New targets have been set in accordance with the remaining objectives.
 - Two new Best Value Performance Indicators have been introduced for contaminated land, BV216a and BV216b. The Strategy now reflect these requirements, and tie in with the local performance indicator for site inspections.
- 3.3 This plan is seen as an important document ensuring that objectives and performance targets are met to continually improve land quality within the Wyre Forest District.

4.1 The adoption of this amended document will reflect current guidance and changes in legislation.
