Terms of Reference

THE CABINET

- 1. Guides and co-ordinates the overall direction of the Council through the formulation of Corporate Plans, Objectives, Priorities and Programmes.
- 2. Together with the Scrutiny Committees, keeps under review the effectiveness of all the Council's activities and the standards and levels of services provided and identifies the need for new services.
- 3. Considers, co-ordinates and recommends to the Council new policies, or changes in existing policies.
- 4. Makes decisions within the budget and policy framework determined by the Council.
- 5. Is able to establish Task Groups small in size, which may be time-limited.
- 6 Discharges any function of the Council not specifically assigned to any other Committee.
- 7. Respects the political neutrality of Officers.
- 8. Reviews establishments and formulation of staffing budgets, except where specifically referred to the Council.
- 9. Reviews management allocation, control and use of staffing resources of the Council.
- 10. Reviews Health, Safety and Welfare of all employees.
- 11. Considers Industrial Relations.
- 12. Considers the interpretation of National Agreements together with the formulation and interpretation of Local Conditions of Service.
- 13. Reviews bonus and job evaluation schemes.
- 14. Is responsible for the authorisation of:-
 - (i) early retirement; or
 - (ii) the dismissal on grounds of redundancy of an employee and the terms applicable thereto (except in the case of the Chief Executive and JNC Officers).
- 15. Receives reports from the Appointments and Appeals Committee where there is a significant additional financial commitment.
- 16. Considers the grading of all posts, remuneration and conditions of service, sick pay, allowances of all kinds, superannuation, gratuities, awards, extensions of service and provision of telephones.
- 17. Ensures the Council complies in all its functions with its obligations under existing and future legislation including Health and Safety at Work etc., Act 1974, the Race Relations Act 1976; the Sex Discrimination Acts 1975 and 1986; the Disability Discrimination Act 1995; and the Employment Rights Act 1996.
- 18. Approves the Council's policy for the education, training and career development of all employees.
- 19. Receives reports from the Chief Executive and/or Head of Human Resources under the Council's employee grievance procedure.
- 20. Responds to consultation papers following consideration of recommendations from the relevant scrutiny committee, where appropriate.
- 21. In consultation with the Corporate Management Team, allocates Area Based Grants, following the issue of guidance from the Department for Communities and Local Government and evidence in relation to the Stronger and Safer Communities Grant. (Council 27/02/08 Minute C.82 27/02/08)
