I have been heavily involved in the planning of the new children's play area which has been provided in Truro Drive and have worked closely with the Habberley Tenants Consultative Committee and Wyre Forest community Housing. The play area is being constructed in phases. The third stage has now been completed. The work to fund and plan stage four is ongoing and good progress is being made.

I have issued 6 newsletters during the last year which gives my name and contact details. This keeps the electorate informed and helps them to contact me if they wish to.

I have dealt with many problems and complaints made to me by residents of the ward throughout the year. These vary considerably from planning and housing issues, the state of the roads, and some very complicated issues such as boundary problems and other complex issues.
