LIC.2 Appointment of Substitutes

Councillor G H Eeles was appointed as a substitute for Councillor H J Martin.

LIC.3 Declaration of Interests

Councillor M B Kelly advised that he had held conversations with Mr Owen, from the Taxi Trade and Mr Bianco the Proprietor of P and P Central Taxis but he came to the meeting with an open mind.

LIC.5 Application to Renew a Hackney Carriage Proprietor's Licence Beyond the Council's Adopted Age Policy of Age Criteria (1997)

A report was considered from the Director of Planning and Regulatory Services that asked the Committee to consider an application for the renewal of a hackney carriage proprietor's licence for hackney carriage number HC077 by Mr Bianco of P and P Central Taxis as it fell outside the Age Criteria Policy set by the Council in 1997.

The Principal Licensing officer informed Committee members that each of the vehicles to be inspected would be taken to an area at the back of the Civic Hall

where they could be inspected in a private area of the car park.

Members had received copies of the application to renew the licence, associated correspondence, copy of the vehicle inspection form and a letter of support from Automotive Engineering regarding the vehicles' mechanics.

Members were informed that the Council had set an age limit of 7 years for each hackney carriage vehicle with exceptions granted to specialist vehicles. The Committee was therefore asked to consider and inspect each vehicle in turn to determine whether the licence could be extended or not.

Mr Bianco was present at the meeting and was accompanied by Mr Owen from the taxi trade who spoke on his behalf. Members were informed that Mr Bianco's fleet of taxis was made up of 50/50 wheel chair accessible vehicles and saloon cars.

Committee Members left the Civic Hall with Officers to inspect vehicle registration number BF02 MLZ (Hackney Carriage Licence HCO77).

Members of the Committee, the Solicitor and Principal Committee Officer returned to the meeting to deliberate their decision. Mr Bianco, Mr Owen, the Principal Licensing Officer and the Licensing Manager remained outside whilst the Committee reached their decision.

Members of the Committee, the Solicitor and Principal Committee Officer returned to the meeting to deliberate their decision. Mr Bianco, Mr Owen, the Principal Licensing Officer and the Licensing Manager remained outside whilst the Committee reached their decision.

Whilst considering their decision Members commented that they considered that there should be a more vigilant inspection of the vehicles. Members noted that not all the boxes on the inspection form had been filled in and they wanted consistency. The Principal Licensing Officer agreed to address this point.

DECISION:

- 1. Having carefully considered the application to grant a Hackney Carriage Proprietor's Licence in respect of vehicle registration number FM51 JXR the Committee decided that a Hackney Carriage Proprietor's Licence HC049 vehicle number FM51 JXR be granted for twelve months from 1st July 2009 to 30th June 2010 subject to the following:
 - The interior carpet needs replacing and
 - The front passenger door handle needs attention due to rust and this would need to be rectified by the time of the next inspection.
- 2. The Principal Licensing Officer to address the issue of the Vehicle Licensing Testing Form being filled out in a consistent manner.

- The inside back panel needs attention and
- The interior needs attention and this would need to be rectified by the time of the next inspection.
