1. PURPOSE OF REPORT

1.1 To agree a revised political balance and note the change of name of a Programme Board.

2. **RECOMMENDATION**

The Council is asked to DECIDE that:

- 2.1 Approval be given to the revised political balance.
- 2.2 The name of the Centralised Office and Transformational Change Board be changed to The Transformation Board.

3. BACKGROUND

- 3.1 Section 15(5) of the Local Government and Housing Act 1989 sets out the principles for the allocation of seats on committees between the political groups on the Council.
- 3.2 Since the last political balance sheet was agreed at Council 30th September 2009, Councillor J A Shaw was elected as the Labour Member for Areley Kings and Councillor S C Meekings has become a Member of the Conservative Group.

4. KEY ISSUES

- 4.1 The Council is required under its constitution to consider any changes to terms of reference.
- 4.2. Under the Local Government and Housing Act 1989 Section 15 2 (b) states that the Council is required to consider a revised political balance "as soon as practicable after any occasion on which the members of the committee are changed in consequence of a determination under this section."

5. FINANCIAL IMPLICATIONS

5.1 There are minor financial implications as a result of the revised political balance and minor amendments to committee membership.

6. LEGAL AND POLICY IMPLICATIONS

6.1 The changes to Terms of Reference and political balance accord with relevant legislative requirements.

7. EQUALITY IMPACT NEEDS ASSESSMENT

7.1 An equality impacts needs assessment has been undertaken but it is not considered there are any impacts on the six equality strands.

8. RISK MANAGEMENT

- 8.1 There are no significant risk management issues associated with the proposed changes to the Terms of Reference in the Council's Constitution.
- 8.2. The Council is required to produce a revised political balance as soon as practicable.

9. **CONCLUSION**

9.1 The amendments to the Terms of Reference and Political Balance have been carried out in accordance with the required legislative requirements.

- 1. Each member is required to notify the Proper Officer which political group, if any, he or she wishes to be identified with. A group comprises of two or more members.
- 2. Each Group Secretary is required to notify the Proper Officer which members of his or her groups he/she wishes to sit on each relevant committee or sub-committee.
- 3. The allocation of seats required the rounding up or down of calculated figures to give whole numbers.
- 4. Single party reps and independent members (who don't form part of a political group) aren't legally entitled to seats on Committee's to which the rules of proportionality apply.
