## 1. PURPOSE OF THE REPORT

## 3. BACKGROUND

- 3.1 The DCLG produces quarterly statistics relating to numbers, types and speed of decision reached by Local Planning Authorities. At the Committee meeting in November 2009, Members were advised of the statistics for the periods April to June 2009.
- 3.2 For reasons which are unclear, the official published statistics for the period July to September 2009 did not include figures for 3 of the Worcestershire District Councils, including Wyre Forest District Council. Upon enquiry, the DCLG have been unable to provide a satisfactory explanation for the omission of these figures, which were provided by officers within the required time period. No report was therefore brought before Members in February 2010, as in the absence of these figures, no meaningful comparison details could be provided for that period.
- 3.3 This report provides the statistics for the period October to December 2009 based on the Statistical Release published in March 2010.

#### **PERFORMANCE**

- 4.1 I have reproduced below the figures for the Worcestershire Districts for the period October to December 2009.
- 4.2 It should be noted that, for reasons unknown, the published Statistical Release does not include year ending figures in respect of City of Worcester Council on this occasion.
