PL.12 Planning Enforcement Matters

10/0048/ENF Unauthorised erection of front and side garden walls at a property in Kidderminster

The house is situated to the south of Kidderminster town centre and forms part of a modern estate of detached dwellings.

The Planning Enforcement Team were first alerted to the construction of a wall

enclosing the front garden of the property in March 2010. The contractor was verbally advised on site that the wall breached planning control as it was sited at the back of the pavement and it exceeded 1 metre in height.

Subsequent research of the planning history revealed that there was a condition attached to the 1985 planning consent which places a greater restriction on boundary treatment.

Officers visited the estate and discovered that the property was the only one which had an enclosing wall and the remainder of the estate was open plan with no hedges or walls.

Members of the Committee were advised that a retrospective planning application had now been received.

Decision: To await the outcome of the planning application.
