# 1. PURPOSE OF REPORT

1.1 To recommend to Council the outcome of the consultation on a review of polling districts and places within Wyre Forest.

# 2. **RECOMMENDATION**

The Chief Executive recommends to Council:

- 2.1 To consider the responses to the consultation; and
- 2.2 To decide that the changes to the polling places as set out in paragraph 4.3 be made.
- 2.3 To note that a further review of polling places will be undertaken later in 2011, in particular to address the issues mentioned in paragraph 3.4.

### 3. BACKGROUND

- 3.1 The Electoral Administration Act 2006 introduced a duty on all local authorities in Great Britain to review their polling districts and polling places once every four years. The last such review in Wyre Forest was undertaken in 2007 and the results were agreed by Council on 28 November 2007.
- 3.2 Following the Elections held May 2010 comments were received from members of the public, elected members and the Acting Returning Officer on the adequacy of some of the premises used as polling stations.

- 3.3 Consultation with the public and key stakeholders commenced on 8<sup>th</sup> November 2010 and concluded on 5<sup>th</sup> January 2011. A copy of the consultation document is attached as Appendix 1. This was carried out via the website and the Hub and Libraries. Full copies of the comments received during this period are contained within Appendix 2 (available electronically) and a summary of them is in Appendix 3 attached to this report.
- 3.4 The issues covered by this review were considered by the Transformation Board on 1<sup>st</sup> February. The Board supported the changes proposed in paragraph 4.3 below and identified the following issues which would require a further review of polling places later in 2011:
  - The Sure Start Centre, Radford Avenue (BR/D) will close when St George's Primary School is completed in 2012. An alternative location will be required for 2012 onwards:
  - Proposals being considered by the county council may see the Youth Centre at Stourport relocated to the High School site. If this is confirmed, again an alternative location will be required;
  - The future of the Walshes Community Centre is being reviewed and again there is a
    possibility that it will cease to be available.

### 4. KEY ISSUES

- 4.1 The review has identified that some polling stations were not suitable, particularly in terms of poor or no access for disabled people. Others polling stations have low numbers of voters which makes them disproportionately expensive.
- 4.2 The review can also take account of known future changes, for example in terms of buildings that will cease to be capable of being used as polling stations in the near future and new buildings that are due to become available.
- 4.3 Detailed below is a summary of the changes that are proposed following the formal consultation process:

4.4 Where the new location is further away, a change of polling place may affect people's propensity to vote for a variety of reasons. Following the Council's decision about what changes to implement, steps will be taken to raise awareness of the availability of postal votes on demand so that electors are reminded of the options available to them to participate in the democratic process.

# 5. FINANCIAL IMPLICATIONS

- 5.1 A review of the polling places within the district offers an opportunity to rationalise and reduce costs without making the process of voting unduly difficult for the electorate.
- 5.2 It is estimated that implementation of the proposed changes will realise savings of approximately £6000.

# 6. LEGAL AND POLICY IMPLICATIONS

- 6.1 Section 18B(4)(e) of the Representation of People Act 1983 states the polling place for a polling district must be small enough to indicate to electors in different parts of the district how they will be able to reach the polling station.
- 6.2 A polling district is a geographical area created by the sub division of a constituency, ward or division into smaller parts.
- 6.3 The Electoral Commission uses the following definitions:
  - A polling place is defined as the building or area in which a polling station will be selected by the (Acting) Returning Officer.
  - A polling station is the room or area within the polling place where voting takes place. Unlike polling districts and polling places which are fixed by the local authority, polling stations are chosen by the (Acting) Returning Officer for the election.

# 7. EQUALITY IMPACT NEEDS ASSESSMENT

7.1 The recommendations will enable the Council to meet its requirements under the Disability Discrimination Act and subsequent legislation by ensuring that access to polling stations meets the needs of all electors.

# 8. RISK MANAGEMENT

8.1 There are no significant risk management issues identified with this report.

### 9. CONCLUSION

9.1 The Council has undertaken comprehensive consultation with key stakeholders and the recommendations above were supported at the Transformation Board Meeting at its meeting on 1<sup>st</sup> February 2011.
