C.48 Conferment of title of Honorary Alderman

The Council had before it the recommendation of the Cabinet from its 26th June 2008 meeting to confer the title of Honorary Alderman upon former District Councillor John Simmonds in recognition of his outstanding service to the authority and the local community over many years.

The Leader of the Council expressed his great pleasure in proposing that the title of Honorary Alderman be conferred upon John Simmonds. In his speech he related details of the commitment to serving the community, reminding Council of the positions he had held in local politics. He reminded the Council of a number of interesting anecdotes and referred to John

Simmonds interest in trees and other rural concerns. The Leader also drew attention to the support Mrs Simmonds had given her husband in his role as a Councillor. Councillor Hart articulated his delight in seconding the motion and recounted some of John Simmonds political achievements.

Group Leaders and other Councillors congratulated John Simmonds on his receipt of the title of Honorary Alderman. They paid tribute to his outstanding achievements and his long and dedicated service to the community and the inspiration and assistance he had given his fellow Councillors.

On behalf of Officers past and present, the Chief Executive added his congratulations and acknowledged the 50 years that John Simmonds had given in public service. The Chief Executive paid tribute to John Simmonds astuteness as a politician, his popularity with all parties and his ability to maintain a position of influence within the Council.

When the formal resolution had been passed, as set out in the decision below, the Chairman of the Council presented John Simmonds with his Badge of Office of Honorary Alderman and commemorative scroll. He also presented a small gift and bouquet of flowers to Mrs Simmonds.

John Simmonds unveiled a plaque in the Council Chamber inscribed with his name as Honorary Alderman.

The Council's first Honorary Alderman Mrs Mills added her congratulations. She explained that is was a great honour to be present at the meeting and was delighted that the Council recognised the contribution that John Simmonds had made to public life. She further thanked the Council for the generous welcome that she had been shown adding that it was lovely to be amongst friends. Alderman Mills received prolonged applause from all present at the meeting.

John Simmonds then thanked the Council for the award and for making him feel so welcome. He related a number of entertaining anecdotes about his life in public service and also expressed his thanks to the people of Rock Parish for their continued support. He further thanked all Councillors and staff, past and present for their support during his time as a Councillor.

At the conclusion of the meeting John Simmonds received a lengthy ovation from all present at the meeting.

Decision

- (a) Pursuant to Section 249 of the Local Government Act 1972, the honour and title of "Honorary Alderman" be bestowed on John Clive Simmonds in grateful recognition of his eminent and distinguished service rendered to Rock Ward and Wyre Forest District Council for 31 years.
- (b) The common seal of the Council be affixed to a scroll conferring the title of Honorary Alderman upon John Clive Simmonds.
- (c) A Badge of Office and scroll be presented to John Clive Simmonds.
