SECTION 136 GRANT AID - BEWDLEY TOWN COUNCIL & STOURPORT TOWN COUNCIL.

1. PURPOSE OF REPORT

1.1 To consider a request by Bewdley Town Council for payment of their £8,018 Section 136 Grant Aid for 2011/2012 and to consider a request by Stourport Town Council for payment of a proportion equating to £6,000 of their Section 136 Grant Aid for 2010/11.

2. RECOMMENDATION

It is recommended that you approve:

- The application from Stourport Town Council for £6,000 from their Section 136 Grant Aid for 2010/11;
- The application from Bewdley Town Council for £8,018 representing the full amount of their Section 136 Grant Aid for 2011/12.

3. BACKGROUND

- 3.1 Wyre Forest District Council has for a number of year provided Section 136 Grant Aid to town and parish councils in excess of the amounts which are raised through their own parish precepts.
- 3.2 The value to the smaller parish councils under this scheme are modest the sums which are payable to the two town councils are more significant. Therefore, each year the Cabinet requires Bewdley and Stourport Town councils to submit proposals on how the funds will be applied before any monies are released. Payments to parishes are paid automatically.
- 3.3 Due to overall budget reduction the value of the grant aid has reduced each year from 2009/10 where a figure equivalent to 15% of the parish precept was paid, whereas in 2011/12 this is now 10%.
- 3.4 This report relates to applications which have been received from Stourport Town Council for a proportion of their funding for 2010/11, and an application from Bewdley Town Council for the full value of the 2011/12 grant.

- 3.5 The proposal for Stourport Town Council for 2010/11 is that £6,000 of the earmarked sum of £21,196 be released at this stage, this will leave a balance of £15,196. The purpose proposed is that the funding be released to provide funding towards the Stourport Forward programme, this is a group that WFDC already supports. The further funding for 2010/11 will be subject to a future application in relation to a number of new initiatives which are being considered.
- 3.6 The proposals for the 2011/12 for Bewdley Town Council are for the full value of the grant and are detailed in the table below:
