LIC.42 Review of the Gambling Act 2005 Statement of Principles

The Committee had considered a report from the Director of Worcestershire Regulatory Services on behalf of Wyre Forest District Council which informed Members of the findings of the recent consultation undertaken with stakeholders on the updated District Gambling Statement of Principles.

The Senior Practitioner – Licensing (WRS) led Members through the report and advised the Statement of Gambling Principles was originally written in conjunction with the County Licensing Group and had been updated by Officers from Worcestershire Regulatory Services, making the document comparable with those held in neighbouring Districts.

The Committee discussed each page of the Draft Statement of Principles, as set out at Appendix 1 of the report to the Licensing and Environmental Committee, in turn.

Councillor J-P Campion left the meeting at this point, (10.44am).

In response to a Members' question about establishing a close working relationship with the Police, as set out at point 17.1 on page 13 of 15, the Senior Practitioner – Licensing (WRS) confirmed the Police Authority employ two civilian Police Licensing Officers who liaised with WRS on a daily basis.

Following a request from a Member, the Senior Practitioner – Licensing (WRS), agreed to invite the Police Licensing Officers to a future meeting of the Committee to provide an update on their work.

The meeting was adjourned at this point, (10.55 am), for the Democratic Services Officer to leave the room to photocopy page 11 of 15 which was missing from the hard copies of the agenda. The page was handed out to Members and the meeting resumed at 11.01am.

1. PURPOSE OF REPORT

1.1 To inform Members of the proposed increases in the fees and charges in respect of the Council's Regulatory Service Function for 2013/2014.

2. RECOMMENDATION

The Committee is asked to RECOMMEND to Council:

2.1 That the proposals for fees and charges within the Council's Licensing, Food, Health, Safety and Pollution Control functions for 2013/2014, as detailed in the report, be included in the 2013/2014 budget strategy.

3. BACKGROUND

3.1 The Council's current financial strategy in respect of fees and charges is to increase them in line with inflation or slightly above. The target increase proposed for 2013/2014 is 5%.

4. **KEY ISSUES**

4.1 A review of licensing fees and charges, for the period 2012/2013, dictates a fee structure based on full recovery of costs.

5. FINANCIAL IMPLICATIONS

- 5.1 It is proposed that fees should be increased by 5 per cent rounded up, where appropriate. A list of the proposed fees and charges for the Council's Licensing, Food, Health, Safety and Pollution Control functions is attached at "Appendix 1".
- 5.2 The budget forecast details the cost versus income for licensing and the costs are based on 2011/2012 as no detailed figures are available for the current year.

6. **LEGAL AND POLICY IMPLICATIONS**

6.1 The agreed income to be generated by the proposed licence fees and charges is in line with the current policy and legislative restrictions. The council is not projected to make any profit on the licensing account for the forthcoming year.

7. RISK MANAGEMENT

7.1 There is a risk that the Councils Regulatory Services Licensing fees and charges could be challenged. To minimise this risk the fees and charges must be designed to meet but not exceed, the cost the Council reasonably believes will be incurred in issuing of licences and the administration of the service.

8. EQUALITY IMPACT ASSESSMENT

8.1 There are no equality impact assessment issues arising from this report.

9. **CONCLUSION**

9.1 The fees and charges are non-profit making and Cost Centres will reflect the operation of the service.
