LIC.17 Review of Standard Licence Conditions Applicable to Animal Welfare Licences

The Committee received a report from the Director of Worcestershire Regulatory Services (WRS) on behalf of Wyre Forest District Council on the review of standard licence conditions applicable to Animal Welfare Licences.

The Senior Licensing Practitioner (WRS) led Members through the report and advised that a review of the standard conditions had been undertaken by Officers to ensure the Council issued licences in accordance with the most up to date guidance and best practice.

Members discussed the draft standards and were informed that to ensure consistency of standards across Worcestershire, the review was being undertaken by (WRS) on behalf of all District Councils across the County.

Agreed:

- 1. The draft standard conditions attached at Appendices 1 to 9 to be attached to future licences issued by the Council under relevant legislation be approved.
- 2. Delegated authority be given to the Director of Economic Prosperity and Place to amend these standard conditions as appropriate in the circumstances of an individual case by altering, omitting or adding conditions as recommended by a veterinary practitioner or veterinary surgeon appointed in accordance with the relevant legislation to inspect the premises subject to the licence application.

LIC.18 Licensing Act 2003 - Review of Statement of Licensing Policy

The Committee received a report from the Director of (WRS) on behalf of Wyre Forest District Council on a draft revised Statement of Licensing Policy.

The Senior Licensing Practitioner (WRS) led Members through the report and advised that following approval by the Committee in August 2014, a consultation with all relevant parties on the draft revised Statement of Licensing Policy was undertaken for a period of 12 weeks.

Members were reminded the policy had been completely redrafted and was based on a template provided by the Local Government Association. It was intended for all of the licensing authorities in Worcestershire to adopt a Statement of Licensing Policy based on this template.

Agreed: To recommend to Council that the revised Statement of Licensing Policy attached at Appendix 1 be approved and published with effect from 11th December 2014.

1. PURPOSE OF REPORT

1.1 To inform Members of the proposed increases in the fees and charges in respect of the Council's Regulatory Service Function for 2015/2016.

2. **RECOMMENDATION**

The Committee is asked to RECOMMEND to Council:

2.1 That the proposals for fees and charges within the Council's Licensing, Food, Health, Safety and Pollution Control functions for 2015/2016, as detailed in the report, be included in the 2015/2016 budget strategy.

3. BACKGROUND

3.1 The Council's current financial strategy in respect of fees and charges is a proposal to increase the said fees and charges for 2015/16 by 5%.

4. KEY ISSUES

- 4.1 A review of licensing fees and charges, for the period 2014/2015, has resulted in a fee structure based on full recovery of costs.
- 4.2 Following a review of the Taxi licensing account, Worcestershire Regulatory Services have recommended that there should be no increase in taxi licensing fees and charges for the forthcoming financial year.

5. FINANCIAL IMPLICATIONS

5.1 It is proposed that all fees with the exception of Taxi Licensing fees and those statutory fees (which include the Licensing Act 2003 applications) set by Central Government should be increased by 5 per cent rounded up, where appropriate. A list of the proposed fees and charges for the Council's Licensing, Food, Health, Safety and Pollution Control functions is attached at "Appendix 1".

- 5.2 The budget forecast details the cost versus income for licensing and the costs are based on 2013/2014 as no detailed figures are available for the current financial year.
- 5.3 Excluding the Taxi Licensing fees and those statutory fees set by Central Government, the budget forecast details for 2015/16 (which include the 5% increase) show no projected profit will be made in respect of the activities whose fees have been increase in the list of proposed fees and charges attached at "Appendix 1".

6. LEGAL AND POLICY IMPLICATIONS

6.1 The agreed income to be generated by the proposed licence fees and charges is in line with the current policy and legislative restrictions. The Council is not projected to make any profit on the licensing activities for which the proposed fees are being increased for the forthcoming year.

7. RISK MANAGEMENT

7.1 There is a risk that the Council's Regulatory Services Licensing fees and charges could be challenged. To minimise this risk the fees and charges must be designed to meet but not exceed, the cost the Council reasonably believes will be incurred in issuing of licences and the administration of the service.

8. EQUALITY IMPACT ASSESSMENT

8.1 There are no equality impact assessment issues arising from this report.

9. CONCLUSION

9.1 The fees and charges are non-profit making and Cost Centres will reflect the operation of the service.
