The Wyre Forest District Council (Off Street Parking Places) Order 2015

1. PURPOSE

To seek approval from the Leader of the Council to make the above Order which reflects the amendment to the boundary of the Dog Lane Car Park, Bewdley publicised in accordance with the Road Traffic Regulation Act 1984. Further to seek approval for making a later Order to put into effect the change to the boundary of the Aldi Car Park also previously approved and published.

2. **RECOMMENDATION**

That the Leader:

Approves the making of the Wyre Forest District Council (Off Street Parking Places) Order 2015 putting into effect the change in boundary to Dog Lane Car Park, Bewdley.

Subject to the consent of Worcestershire County Council, approves the making of the Wyre Forest District Council (Off Street Parking Places) Order 2015 (Number 2) putting into effect the change in boundary to the Aldi Car Park, Kidderminster.

3. **BACKGROUND**

The Strong Leader decision (delegated to the Cabinet Member for Operational Services) of 10th March 2015 approved that various amendments to the Parking Order be advertised and that any consultation responses be considered. The variations in relation to Dog Lane and Aldi Car Parks have been advertised and no responses to the consultation have been received.

Approval is now required to make each of the Orders to reflect these changes. Due to the different construction timetables the variations will need to be made separately, the latter Order (Aldi) replacing the first.

4. **CONSULTATION**

The variations have been advertised and consultation letters sent in accordance with the relevant legislation. Approval is also required from the County Council, this has been received in relation to Dog Lane and is awaited

for the Aldi variation. The decision requested is subject to approval from the County Council in relation to Aldi Car Park.

Upon making each Order it is required by legislation that a further notice is published in the local press stating that the Orders have been made.

5. FINANCIAL IMPLICATIONS

The cost of advertising the Orders will be met from within existing budgets. Any revenue consequences associated with reducing and increasing the car park spaces have already been dealt with separately in considering the individual proposals under separate cover.

7. LEGAL AND POLICY IMPLICATIONS

The authority to make the Orders fulfils the legal requirements associated with the process of changing the existing Parking Order.

8. CONCLUSION

That the Orders should be made to put into effect the changes to the existing Parking Order already approved.

9. RISK MANAGEMENT

The development of the medical centre intended for the Dog Lane Car Park site and the Aldi store extension cannot progress without the formal making of the Orders.
