## CAB.23 Apologies for Absence

## CAB.26 Options Appraisal for Demolition of Glades Leisure Centre

A report was considered from the Director of Economic Prosperity and Place which set out the options appraisal for the demolition of the Glades Leisure Centre and asked Cabinet to agree whether or not to proceed with the demolition. If agreed the Cabinet were also asked to agree the process for deciding the model for evaluating the tender submissions to carry out the demolition work.

The Leader of the Council presented the confidential report and formally moved the recommendations. He advised that following approval of the Kidderminster Eastern Gateway (KEG) Development Framework by Cabinet at its meeting on 12<sup>th</sup> July 2016, the demolition of the redundant building by the Council would support the early delivery of the first parcel of land, and give a clear message that the land was ready and available for development.

The Cabinet Member for Planning and Economic Regeneration welcomed the professional advice from Savills, who had undertaken soft market testing of the site, and seconded the recommendations, adding that the process for marketing and redeveloping the site could begin.

The Cabinet Member for Resources spoke in support of the recommendations. He stated that demolishing the building would have clear financial benefits to the Council in that revenue costs would be reduced and having an empty building that was no longer fit for purpose would only act as a magnet for anti-social behaviour.

The Cabinet Member for Operational Services stated that the Council must do whatever was necessary to kick-start the regeneration of the site and supported the recommendations. The Cabinet Member for Health, Well-being and Housing fully agreed with the proposals and was looking forward to the work getting underway.

#### **Decision:**

- 1. The demolition of the Glades former Leisure Centre be undertaken by the Council.
- 2. Delegation of the procurement evaluation model and award of the contract be granted to the Director of Economic Prosperity & Place in consultation with the Cabinet Member for Planning & Economic Regeneration, as set out at 2.2 in the exempt report to Cabinet.
- 3. Take the other consequential steps identified in paragraphs 2.3 and 2.4 of the confidential report to Cabinet.

There being no further business, the meeting closed at 6.22pm.
