LIC.15 Apologies for Absence

Apologies for absence were received from Councillors: J D Smith and R J Vale.

LIC.16 Appointment of Substitutes

Councillor C Rogers was a substitute for Councillor J D Smith.

LIC.17 Declaration of Interests

No declarations of interest were made.

LIC.18 Minutes

Decision: The minutes of the meeting held on 3rd October 2016 be confirmed as a correct record and signed by the Chairman.

LIC.19 Review of Fees and Charges for the Council's Licensing and Regulatory Services Function 2017/18

The Committee received a report from the Head of Worcestershire Regulatory Services (WRS) on behalf of Wyre Forest District Council which informed Members of the recent review of the Council's Licensing and Regulatory Services Function fees and charges, and the proposal to increase the fees and charges for the financial year 2017/18.

Councillor M Rayner entered the meeting at this point (10.33am).

The Senior Practitioner – Licensing (WRS) led Members through the report and advised that following a review of the Scrap Metal Dealers Act 2013 account, Sex Establishments account and Taxi Licensing account, WRS had recommended that there should be no increase in these fees and charges for

the forthcoming financial year. He added that the Council's Regulatory Services Licensing fees and charges were non-profit making and were designed to meet but not exceed the cost in issuing licences and the administration of the service.

Members were informed that following a review of the Taxi Licensing plates, a decision had been taken to include an expiry date on the plates which are displayed on the vehicles. The Senior Practitioner – Licensing advised that new plates would need to be re-issued annually on renewal of the licence, and following a review of the fees WRS were satisfied that the cost of issuing new plates could be absorbed within the existing budget for the first year. However, when the annual review of fees and charges takes place in the autumn of 2017, it may be that there needs to be a suitable increase to cover the cost of this function.

In conclusion, Members were advised it was proposed that all fees, with the exception of Scrap Metal Dealers, Taxi Licensing, Sex Establishments and those statutory fees set by Central Government, which include the Licensing Act 2003 applications, are increased by 5%.

The recommendation as set out in the report to the Licensing and Environmental Committee were proposed and seconded. Upon a show of hands the recommendation was carried by a majority vote.

Decision: Recommend to Council:

That the proposals for fees and charges within the Council's Licensing, Food, Health, Safety and Pollution Control functions for 2017/18, as detailed in the report, be included in the Council's 2017/18 budget strategy.

LIC.21 Application for the Grant of a Hackney Carriage/Private Hire Driver's Licence

The Committee received a report from the Director of Economic Prosperity and Place that asked Members to consider an application for the grant of a Hackney Carriage/Private Hire Driver's Licence.

The Senior Practitioner – Licensing (WRS) led Members through the report and highlighted the relevant convictions listed on the DBS disclosure form which was circulated to Members at the meeting.

The applicant addressed the Committee and asked Members to support his application. Following questions from Members, the applicant outlined the

circumstances surrounding his previous convictions and explained the reason behind his career change, and the desire to do the best for his young daughter.

The Senior Practitioner – Licensing and applicant left the meeting at this point, (10.55am), for Members to deliberate their decision. The Solicitor and the Principal Committee and Member Services Officer stayed in the meeting whilst the Committee reached their decision.

The Senior Practitioner – Licensing and applicant re-entered the meeting at this point, (11.14am). The Solicitor read out the decision of the Committee.

Decision:

Having carefully considered the application to grant a Hackney Carriage/Private Hire Driver's Licence to the applicant, the Committee has decided that notwithstanding the applicant's previous convictions and the guidance contained in Council's "Guidelines relating to the Relevance of Convictions", the Committee are satisfied that the applicant is a "fit and proper person" to be granted such a Hackney Carriage/Private Hire Driver's Licence and it is justified in departing from the Council's "Guidelines relating to the Relevance of Convictions" because of the exceptional circumstances presented to the Committee that:

- 1. the two convictions for offences of violence were committed over 12 and 9 years ago and since those convictions no further convictions of violence have been recorded;
- 2. the applicant appears to the Committee to now be a good citizen, who has shown that he has been in steady employment, which due to medical reasons he has now decided to move on from, and that the applicant has now settled down and wants to do the best for his young daughter.

There being no further business, the meeting ended at 11.16am.
