Amendments to the Pre-Submission Policies Map

Introduction

- i The Wyre Forest District Policies Map (formerly the Adopted Site Allocations and Policies DPD and Kidderminster Central Area Action Plan DPD Policies Map (July 2013)), will spatially show all land use policies for the district as set out in the emerging Local Plan. It will:
 - Identify areas of protection such as Green Belt, SSSI, and Conservation Areas as defined through the strategic planning process.
 - Allocate sites for particular land use and development.
- ii The policies and proposals included in the Wyre Forest District Local Plan Pre-Submission publication document (October 2018) resulted in the need to make changes to the adopted 2013 Policies Map. This version of the Policies Map (referred to in this document as the Local Plan Pre-Submission Policies Map (October 2018)), was consulted on as part of the Local Plan Pre-Submission consultation held in November/December 2018.
- iii In September 2019 the Council will re-open the consultation on the Local Plan Pre-Submission document for six weeks, following Cabinet approval on 16 July 2019. Further updates have been made to the Policies Map for this Local Plan Pre-Submission consultation (20 19). This version of the Policies Map is referred to in this document as the Local Plan Pre-Submission Policies Map (July 2019).
- iv Tables 1 to 3, in this document set out the changes that have been made to the Wyre Forest District Policies Map which consist of amendments as well as additions and a number of deletions.
