The site has dual access from both a private track and from a newly constructed access utilising an existing dropped curb onto the A449. Although there are no known accidents associated with the access point, it's construction is not in accordance with Highway standards for a means of access onto an A class road. Access improvements are therefore required to ensure the access is compliant and a condition should be imposed to ensure sufficient visibility splays and a 45 degree fence line either side of the gate which should be set back 10 metres with a permeable hard surface.
	27	Please refer to condition 8 in report, which states: Within 3 months of the date of permission, the layout of the existing vehicular access shall be amended to include visibility splays and a 45 degree fence line either side of the access with gates set back 10 metres from the edge of the carriageway and the access area surfaced in a bound material. Details are to be submitted in writing to and approved by the Local Planning Authority. Reason In the interests of highway safety
