1. PURPOSE OF REPORT

- 1.1 To consider and determine an application for grant of a premises licence in respect of:

**Sterling Ale And Ciders Ltd
21 Bull Ring
Kidderminster
Worcestershire
DY10 2AZ**

A copy of the application is attached at “**Appendix 1**”.

2. BACKGROUND

2.1 On 30 June 2020 an application was received from Adam Michael Wilcox for grant of a premises licence in respect of:

Sterling Ale And Ciders Ltd
21 Bull Ring
Kidderminster
Worcestershire
DY10 2AZ

2.2 The application contained all the requisite documentation including the fee and a plan of the premises. A copy of the plan that accompanied the application is shown at “**Appendix 2**”.

2.3 It can be confirmed that the application has been advertised in accordance with the requirements of the Licensing Act 2003 and associated regulations and that the application has also been served on all responsible authorities.

2.4 The applicant is applying for the following licensable activities:-

Activity	Days	From	To	Indoors/Outdoors
Performance of Dance	Everyday	08:00	- 23:00	Indoors
Performance of Live Music	Everyday	08:00	- 23:00	Indoors
Playing of Recorded Music	Everyday	08:00	- 00:00	Indoors
Sale of Alcohol	Everyday	08:00	- 23:30	

(For consumption on and off the premises)

2.5 The designated premises supervisor identified in the application is Adam Wilcox.

2.6 Following consultation with the Police, the applicant agreed to the following amendments to the application:

- the sale of alcohol is to be authorised from 08:00 to 23:30 each day
- conditions agreed with West Mercia Police to be applied to the licence once it has been issued. A copy of these conditions are attached at “**Appendix 3**”.

3. REPRESENTATIONS

Responsible Authorities

- 3.1 All of the responsible authorities have been consulted directly and during the consultation period no representations were received from any of the responsible authorities in relation to this application.

Other Persons

- 3.2 One representation have been received from other persons. The representations make mention of concerns linked to the licensing objective of prevention of public nuisance, public safety and the prevention of crime and disorder. A copy of the representation can be seen at “**Appendix 4**”.

4. LOCAL POLICY CONSIDERATIONS

- 4.1 The Sub-Committee should have regard to the Council’s Statement of Licensing Policy under the Licensing Act 2003.
- 4.2 The Council’s Statement of Licensing Policy is available to download from the Council’s website or to request a hard copy, contact Worcestershire Regulatory Services on 01905 822799 or email enquiries@worcsregservices.gov.uk
- 4.3 The Sub-Committee’s attention should be drawn to the following **Paragraphs 5.3 - 5.6** of the Council’s Statement of Licensing Policy in respect of this application generally:

(5.3)The licensing authority will aim to carry out its licensing functions in a way that promotes tourism, increases leisure and culture provision and encourages economic development within the District.

(5.4) However the licensing authority will also always try and balance the needs of the wider community, local community and commercial premises, against the needs of those whose quality of life may be adversely affected by the carrying on of licensable activities, particularly within residential areas.

(5.5) In particular the licensing authority will attempt to control any potential negative impacts from the carrying on of licensable activities, such as increased crime and disorder, anti-social behaviour, noise, nuisance, risks to public safety and harm to children.

(5.6) The licensing authority’s aim is to facilitate well run and managed premises with licence holders displaying sensitivity to the impact of the premises on local residents.”

5. LICENSING OBJECTIVES

- 5.1 The representation received objecting to the grant of the application raise concerns about the prevention of “Crime and Disorder” and “Public Nuisance”, licensing objectives.

Crime and Disorder

- 5.2 **Paragraph 2.1** of the s182 Guidance (April 2018) states: “Licensing authorities should look to the police as the main source of advice on crime and disorder”.

- 5.3 In addition to **Paragraph 2.1** of the s182 Guidance referred to above and the subsequent paragraphs of that section, the Sub-Committee’s attention is also drawn to **Paragraphs 6.11 - 6.19** of the Council’s Statement of Licensing Policy relating to the Prevention of **Crime and Disorder** in respect of this application.

Public Nuisance

- 5.2 **Paragraph 2.15** of the s182 Guidance (April 2018) states:
“The 2003 Act enables licensing authorities and responsible authorities, through representations, to consider what constitutes public nuisance and what is appropriate to prevent it in terms of conditions attached to specific premises licences and club premises certificates. It is therefore important that in considering the promotion of this licensing objective, licensing authorities and responsible authorities focus on the effect of the licensable activities at the specific premises on persons living and working (including those carrying on business) in the area around the premises which may be disproportionate and unreasonable. The issues will mainly concern noise nuisance, light pollution, noxious smells and litter.”

- 5.3 In addition to **Paragraph 2.15** of the s182 Guidance referred to above and the subsequent paragraphs of that section, the Sub-Committee’s attention is also drawn to **Paragraphs 6.24 - 6.29** of the Council’s Statement of Licensing Policy relating to the Prevention of Public Nuisance in respect of this application.

Public Safety

- 5.4 **Paragraph 2.7** of the s182 Guidance (April 2018) states:
“Licence holders have a responsibility to ensure the safety of those using their premises, as a part of their duties under the 2003 Act. This concerns the safety of people using the relevant premises rather than public health which is addressed in other legislation. Physical safety includes the prevention of accidents and injuries and other immediate harms that can result from alcohol consumption such as unconsciousness or alcohol

poisoning. Conditions relating to public safety may also promote the crime and disorder objective as noted above. There will of course be occasions when a public safety condition could incidentally benefit a person's health more generally, but it should not be the purpose of the condition as this would be outside the licensing authority's powers (be ultra vires) under the 2003 Act. Conditions should not be imposed on a premises licence or club premises certificate which relate to cleanliness or hygiene."

5.5 In addition to **Paragraph 2.7** of the s182 Guidance referred to above and the subsequent paragraphs of that section, the Sub-Committee's attention is also drawn to **Paragraphs 6.20 - 6.23** of the Council's Statement of Licensing Policy relating to Public Safety in respect of this application.

6. LEGAL IMPLICATIONS

6.1 The Sub-Committee is obliged to determine this application with a view to the promotion of the licensing objectives which are:

- the prevention of crime and disorder;
- public safety;
- the prevention of public nuisance;
- the protection of children from harm.

6.2 In making its decision, the Sub-Committee is also obliged to have regard to the guidance issued by the Secretary of State under section 182 of the Licensing Act 2003 and the Council's own Statement of Licensing Policy.

6.3 The Sub-Committee must also have regard to the representations made and the evidence it hears.

6.4 The Sub-Committee must take such of the following steps as it considers appropriate for the promotion of the licensing objectives:

- (a) Grant the application as requested
- (b) Modify the conditions of the licence, by altering or omitting or adding to them.
- (c) Reject the application in whole or in part.

6.5 The Sub-Committee is asked to note that it may not modify the conditions or reject the whole or part of the application merely because it considers it desirable to do so. It must actually be appropriate in order to promote the licensing objectives.

6.6 All parties to the hearing will be notified of the Sub-Committee's decision in writing within five working days of the conclusion of the hearing.

6.7 Any party aggrieved by a decision taken by the Sub-Committee may appeal against the decision to a Magistrates' Court within 21 days of being notified of the decision in writing.

6.8 The hearing should be conducted in accordance with the agreed procedure.

7. FOR DECISION

- 7.1 The Sub-Committee must consider and determine the application.

Entitlement to work/immigration status for individual applicants and applications from partnerships which are not limited liability partnerships:

A licence may not be held by an individual or an individual in a partnership who is resident in the UK who:

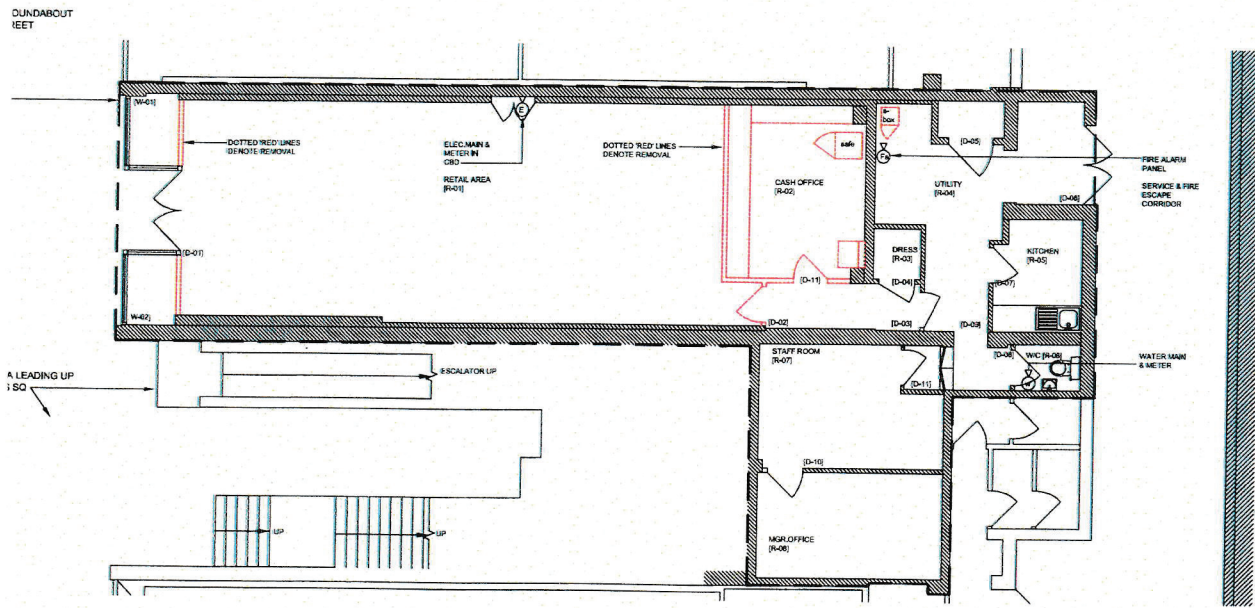

We have spoken to the applicant (in copy) and the following conditions and changes have been agreed with West Mercia Police.

Alcohol Hours – to reduce end time to 23.30 hours daily.

Extra Conditions under Prevention of Crime and Disorder

CCTV

The premises licence holder must ensure that:

- CCTV cameras are located within the premises to cover all public areas including all entrances and exits*
- The system records clear images permitting the identification of individuals.*
- The CCTV system is able to capture a minimum of 4 frames per second and all recorded footage must be securely retained for a minimum of 28 days.*
- The CCTV system operates at all times while the premises are open for licensable activities. All equipment must have a constant and accurate time and date generation.*

· The CCTV system is fitted with security functions to prevent recordings being tampered with, i.e. password protected.

· There are members of trained staff at the premises during operating hours able to provide viewable copies on request to police or authorised local authority officers as soon as is reasonably practicable but within 24 hours at the latest. The CCTV will be provided in accordance with the Data Protection Act 1998 (or any replacement legislation).

Incident Book

The premise must record all incidents that occur on the premise. Incidents that will be included will be first aid incidents, removal of persons by staff, anything that results in an injury and people that have been refused alcohol. If SIA staff are employed in the premise they will record their name and 16 digit SIA badge number and times they worked in the premise. This can be inspected and reviewed by a responsible authority as defined by the Licensing Act 2003. Full training will be given to all staff on how to use the incident book.

Authorisation of Sale of Alcohol

Authorised for the sale of Alcohol will be defined in a written document. This will detail who is authorised the sale of alcohol and evidence that the staff member has been trained to spot underage drinkers. This document will be signed by both the staff member and the DPS. This document will be left on site and will be made available to the police, local authority or any other relevant authority seeking inspection or a copy.

SIA Staff

The premise will employ SIA staff on a risk basis and when requested to do so based on feedback from West Mercia Police or the local licensing authority based on evidence of increased crime and disorder at the venue. When SIA staff are deployed they will wear their badges as per SIA guidelines at all times and sign their details into the incident book.

The first thing Mr Wilcox did when he took over the old penny black pub now called Pennies was to apply for a longer drinks licence until 3am if allowed this is what will happen here

There is no outside area at present for people to sit so if approved people would be allowed to sit outside drinking in a public protection area where drinking is not allowed and also obstruct the public footpath making social distancing very difficult . the close proximity to Mr Wilcox other bar Pennies will also encourage anti-social behaviour in the area outside between the two bars .

Because the area outside is pedestrianised how would this bar be able to get deliveries without obstructing this space and putting public safety at risk .

I hope you look at how this will affect the town centre when making a decision on this application .
