Information which is subject to any obligation of confidentiality.

Information which relates in any way to matters concerning national security.

Declaration of Interests by Members – interests of members in contracts and other matters

Declarations of Interest are a standard item on every Council and Committee agenda and each Member must provide a full record of their interests in the Public Register.

In addition, alongside the Register of Interest, the Members Code of Conduct ("the Code") requires the Declaration of Interests at meetings. Members have to decide first whether or not they have a disclosable interest in the matter under discussion.

Please see the Members' Code of Conduct as set out in Section 14 of the Council's constitution for full details.

Disclosable Pecuniary Interest (DPI) / Other Disclosable Interest (ODI)

DPI's and ODI's are interests defined in the Code of Conduct that has been adopted by the District.

If you have a DPI (as defined in the Code) in a matter being considered at a meeting of the Council (as defined in the Code), the Council's Standing Orders require you to leave the room where the meeting is held, for the duration of any discussion or voting on that matter.

If you have an ODI (as defined in the Code) you will need to consider whether you need to leave the room during the consideration of the matter.

ES.5 Complaints to the Local Government and Social Care Ombudsman 2018/19

The Committee received a report from the Chief Executive on the outcome of complaints to the Local Government and Social Care Ombudsman in accordance with Council Policy for the period of 1st April 2018 to 31st March 2019.

The Solicitor to the Council said the report was very good news. She added that the authority had robust policies and procedures in place for dealing with complaints. She said Officers invested a lot of time in achieving a resolution at a local level.

The Solicitor to the Council assured Members that all complaints had been dealt with fairly and she had no cause for concern.

Agreed: The report be noted.

ES.6 Local Government Ethical Standards

The Committee considered a report from the Solicitor to the Council on a Review by the Committee on Standards in Public Life (CSPL) into Local Government Ethical Standards.

The Solicitor to the Council presented the report and advised Members that In January 2019 the Authority received the Review by the Committee on Standards in Public Life CSPL into Local Government Ethical Standards. The committee concluded that high standards of conduct in local government are needed to protect the integrity of decision-making, maintain public confidence, and safeguard local democracy.

Members were advised that there is also evidence of persistent or repeated misconduct by a minority of councillors, and the CSPL report records that many codes of conduct fail to address adequately important areas of behaviour such as social media use and bullying and harassment.

The Committee considered each page of the proposed draft Code of Conduct in turn, and were content that it met the CSPL best practice recommendations.

The Chairman advised that the revised Code of Conduct would be recommended to Council for adoption in December 2019.

Agreed: Delegated authority be given to the Solicitor to the Council to make appropriate changes to the Code of Conduct to reflect the CSPL Best Practice Recommendations.

There being no further business, the meeting ended at 6.23pm.

1. PURPOSE OF REPORT

- 1.1 To ensure consideration is given to Members having appropriate dispensations in respect of issues relating to the Council's decision making process.
- 1.2 To consider arrangements for granting dispensations and recommend appropriate generic dispensations.

2. RECOMMENDATION

2.1 It is recommended that;

Generic dispensations are given to all Members for a period of 4 years in respect of the matters detailed below:

1. Membership of outside bodies

A general dispensation under s33(2) (c) and (e) of the Localism Act 2011 and under the Code of Conduct to allow the full participation in Council, Committee and other meetings where members of the Council or their spouse or partner are members of or employed by one or more of the following bodies, and who because of this would or could be prevented from participating in such meetings unless a decision relates directly to their own (or spouse or partners) financial circumstances:

- (a) Membership of any parish or town council.
- (b) Membership of Worcestershire County Council.
- (c) Membership of any other body of a public nature to which the member has been appointed as the Council's nominee or representative.
- 2. Addressing committees considering matters in which a member has an interest.

A general dispensation under s33(2)(c) and (e) of the Localism Act 2011 and under the Code of Conduct to allow members who would otherwise be prevented from

doing so to address Council and committees in the same way as a member of the public may

[NB Such a member must still then withdraw from the meeting once they have addressed it.]

3. A general dispensation for members whose spouses are employed by a body of a public nature, unless a decision relates directly to their own financial circumstances.

3. BACKGROUND

- 3.1 Members will recall that when the Localism Act was enacted in 2011 the provisions relating to dispensations were significantly changed. Formerly, a member who had a prejudicial interest could apply to the Standards Committee for a dispensation on two grounds, namely:
 - That at least half of the members of a decision-making body have prejudicial interests; and
 - That so many members of one political party have prejudicial interests in the matter that it will upset the result of the vote on the matter.

The Localism Act introduced wider criteria and empowered a relevant authority, on receipt of a written request, to grant dispensations for up to four years for a member to be able to participate in or vote at meetings where they have a disclosable pecuniary interest.

Authorities may grant dispensations if they consider that by not granting a dispensation, the business of the authority or committee is likely to be impeded; or that

- the political balance of the committee or authority is so upset as to alter the outcome of a vote; or
- that granting the dispensation is in the interests of residents; or that all members of the executive.
- Are unable to participate in business to be carried out by the executive; or that they consider it.
- Appropriate to grant a dispensation for other reason.
