1. PURPOSE OF REPORT

1.1 The purpose of this report is to recommend amending the Capital Programme to include the external funding received from the West Mercia PCC for Community Safety CCTV equipment purchase.

2. RECOMMENDATION

The Leader is asked to **APPROVE** that:

2.1 There is an amendment to the Capital Programme to include expenditure of £24,860 fully matched by external funding to support Community Safety for the purchase of CCTV equipment, to upgrade the existing systems and technologies

3. BACKGROUND

- 3.1 On behalf of the local authorities in North Worcestershire, the North Worcestershire Community Safety Partnership had the opportunity to apply to the West Mercia Police and Crime Commissioner for grant funding to invest in upgrading the existing CCTV sited in all 3 districts.
- 3.2 The 3 local authorities; Wyre Forest, Bromsgrove and Redditch have a joint contract for CCTV maintenance, and the capital upgrade programme will enhance current monitoring capabilities and future proof the CCTV scheme that covers the 3 district areas.

4. KEY ISSUES

4.1 This funding has been awarded to continue the work of the NWCSP CCTV
Upgrade project of 2018 – 20. The new and upgraded cameras have enhanced the capabilities of the scheme and ensuring that the most up to date technology is available to catch and record incidents across the districts. This allows the North

Worcestershire CCTV scheme to continue to be an essential tool in crime reduction, detection and provide valuable reassurance to communities and local businesses in the 3 district areas; Wyre Forest, Bromsgrove and Redditch.

- 4.2 The funding allocated for Wyre Forest will enable the following:
 - To upgrade 3 camera and transmission infrastructure from analogue to digital in Bewdley
 - To upgrade 4 of the 6 cameras in Stourport, utilizing the already installed digital wireless network, to HIK Dark Fighter cameras
- 4.3 The grant application has been successful, and funding needs to be drawn down from Bromsgrove Council

5. FINANCIAL IMPLICATIONS

5.1 The grant from West Mercia PCC paid via Redditch BC is £24,860 this will fully fund the purchase of additional CCTV equipment. This will be capital expenditure so needs to be included in the Capital Programme for 2021-22.

6. <u>LEGAL AND POLICY IMPLICATIONS</u>

- 6.1 Council on the 12th May approved a recommendation from December Cabinet to delegate authority to Cabinet to make amendments to the Cabinet Programme where the Council receives external grants and the resultant expenditure is fully funded.
- 6.2 The procurement of the new equipment is dealt with across the 3 districts and is managed by Bromsgrove and Redditch.

7.1 An Equalities Impact Assessment is not required.

8. RISK MANAGEMENT

8.1 The 3 local authorities have a successful long standing joint agreement in place for CCTV maintenance
