

1. PURPOSE OF REPORT

- 1.1 To decide an extension to the Wyre Forest District Council's scheme for the Local Authority Additional Restrictions Grants (ARG) Fund for businesses affected by the COVID-19 outbreak.

2. RECOMMENDATION

- 2.1 The Leader is asked to **APPROVE** the addendum to the Amended Additional Restrictions scheme set out in Appendix 1.
- 2.2 The Leader is asked to grant delegated powers to the Head of North Worcestershire Economic Development and Regeneration to amend the scheme, if necessary, in response to future announcements by Government relating to restrictions on trade and Covid-19 business support grants.

3. BACKGROUND

- 3.1 On 31 October 2020, the Government announced the introduction of additional support for local authorities under national and Local Covid Alert Level (LCAL) 3 restrictions. This support takes the form of a funding scheme in the financial year 2020-2021 and can be used across the financial years 20/21 and 21/22. The scheme is called the Additional Restrictions Grant (ARG) and is administered by business rate billing authorities in England. In the financial year 2020/21 Wyre Forest DC received an initial allocation of £2,925,553.
- 3.2 Local authorities can use this funding for business support activities. It is envisaged that this will primarily take the form of discretionary grants, but local authorities (LAs) can also use this funding for wider business support activities.

- 3.3 Local authorities can determine how much funding to provide to businesses from the ARG funding provided and exactly which businesses to target.
- 3.4 Local authorities are encouraged to develop discretionary grant schemes to help those businesses which – while not legally forced to close – were nonetheless severely impacted by the restrictions put in place to control the spread of Covid-19.
- 3.5 Local authorities may choose to help businesses outside the business rates system, which are effectively forced to close.
- 3.6 The grant amounts given to individual businesses are subject to subsidy control allowances.
- 3.7 On 22 February 2021, the Prime Minister announced a four-step roadmap to ease restrictions across England and to provide a route back to a normal way of life.
- 3.8 On 17 March 2021, the Government announced a £425m top-up to the Additional Restrictions Grant and published details of each local authority's indicative allocation. To be eligible for the top-up funding, a local authority had to have fully allocated its funding by 30 July 2021. Wyre Forest DC's potential top-up funding was £770,386.
- 3.9 On 19 May 2021, an amended Additional Restrictions Grant policy was approved. The scheme was amended to reflect the impact of the roadmap and to ensure that funds would be allocated by 30 July 2021 and thus Wyre Forest DC would be eligible for the top-up funding.
- 3.10 On 14 June 2021, the Prime Minister announced that the planned date for introducing step 4 of the easing of restrictions would be delayed from 21 June 2021 to 19 July 2021 at the earliest.
- 3.11 The Additional Restrictions Grant funding was fully allocated by 30 July 2021. Consequently, Wyre Forest DC has received the £770,386 top-up funding.
- 3.12 On 30 November 2021, the Prime Minister introduced new restrictions to control the spread of the Omicron variant of Covid-19.
- 3.13 On 21 December 2021, the Chancellor of the Exchequer announced a package of support for the Hospitality and Leisure sectors. Full guidance on the scheme has not yet been published but it will include grants of up to £6,000 to eligible businesses.

4. KEY ISSUES

- 4.1 The Council's existing Additional Restrictions Grant policy was designed to support businesses in the expectation that each of the four steps in the roadmap would be taken on the earliest dates announced by the Prime Minister.

- 4.2 On 16 June 2021, the Government issued revised guidance for the Additional Restrictions Grant which encouraged Local Authorities to use Additional Restriction Grant funding to continue to support those businesses that were significantly impacted by the delay in easing of restrictions.
- 4.3 The grants issued to date related to specific periods of time when restrictions were in place. To date, no Additional Restriction Grants have been issued to cover the period 21 June 2021 to 19 July 2021.
- 4.4 The new measures to control the spread of the Omicron variant of Covid-19, introduced on 30/11/21, are having a significant impact on hospitality businesses. Whilst the restrictions do not directly apply to hospitality venues, businesses are reporting a significant reduction in customer numbers due to the public health messages.
- 4.5 This report proposes an addendum to the current Additional Restrictions Grant policy to provide additional support to businesses directly impacted by the delay in moving to Step 4 of the roadmap and for businesses in the hospitality sector impacted by the outbreak of the Omicron variant.
- 4.6 The addendum also includes a Bounce-Back Grant to help to drive the recovery of businesses that have been impacted by the restrictions that have been in place during the pandemic.
- 4.7 £67,000 of Additional Restrictions Grant funding has been allocated to match-funded business support programmes.
- 4.8 Appendix 1 sets out the full details of the addendum to the Additional Restrictions Grant scheme.
- 4.9 Appendix 2 sets out the existing Additional Restrictions Grant Scheme.

5. FINANCIAL IMPLICATIONS

- 5.1 There are no direct financial implications for the Council as the grant is being administered within existing resources. A payment of new burdens funding has been received. Wyre Forest DC has received £3,695,939 of Additional Restrictions Grant.
- 5.2 To date Wyre Forest DC has awarded £2,937,852 of grants from the Additional Restrictions Grant funding. This leaves a balance of £758,087 yet to be allocated.
- 5.3 Any Additional Restrictions Grant funding that is not spent by 31 March 2022 must be returned to Government.

6. LEGAL AND POLICY IMPLICATIONS

6.1 The Council is a Category 1 responder under the Civil Contingencies Act 2004. The powers upon which the Council will rely in deploying the local authority discretionary grants fund (which the Government will pay under section 31 of the Local Government Act 2003) include section 1 of the Localism Act 2011, the general power of competence, and sections 111 and 137 of the Local Government Act 1972.

7. EQUALITY IMPACT NEEDS ASSESSMENT

7.1 An impact needs assessment is not required as the grant fund is for businesses, rather than individuals in a personal capacity.

8. RISK MANAGEMENT

8.1 The main risks now are perceived to be:

a) presentational: it is anticipated that demand for grants will be greater than available funding. Grants will be awarded on a first come basis and all promotional activity will emphasise that funding is limited;

b) fraud risk: rigorous assessment checks will continue to be undertaken to root out doubtful claims and to refer evidence of attempted fraud to the police.

The proposals in this report seek to mitigate these risks.

9. CONCLUSION

9.1 The Leader is invited to approve the addendum to the Additional Restrictions Grant scheme, as set out in Appendix 1.

9.2 The Leader is invited to delegate authority to the Head of North Worcestershire Economic Development and Regeneration amend the scheme, if necessary, in response to future announcements by Government relating to restrictions on trade and Covid-19 business grants.

FROM 5 JANUARY 2021

(dated 20 December 2021)



1.0 Purpose of the Scheme and background

1.1 The purpose of this document is to:

- determine eligibility for a payment under the Council's Additional Restrictions Grant Scheme in response to the outbreak of the Omicron variant of Covid-19 and the impact on the hospitality sector;
- to provide further support to businesses that were impacted by the delay in moving to Step 4 of the roadmap;
- to set out expenditure plans for the balance of Additional Restrictions Grant funding.

1.2 The Additional Restrictions Grant scheme was developed by the Council in response to an announcement made by the Secretary of State for Business, Energy & Industrial Strategy on 31 October 2020, which set out the basic circumstances whereby an additional restriction grant payment could be made by the Council to a business which had to close or was severely affected due to localised or widespread national restrictions being put in place to manage coronavirus and save lives.

1.3 On 22 February 2021, the Prime Minister announced a four-step roadmap to ease restrictions across England and to provide a route back to a normal way of life. The Additional Restrictions Grant scheme that was approved on 2/5/21 was designed to support businesses in the expectation that each of the four steps in the roadmap would be taken on the earliest dates provided in the original announcement.

1.4 On 14 June 2021, the Prime Minister announced that the planned date for introducing step 4 of the easing of restrictions would be delayed from 21 June 2021 to 19 July 2021.

1.5 As a consequence of this decision, the Government issued revised guidance for the Additional Restrictions Grant on 16 June 2021. The revised guidance encourages Local Authorities to use Additional Restrictions Grant funding to continue to support those businesses that are significantly impacted by the delay in easing of restrictions. The guidance identifies nightclubs, and the tourism, events and wedding industries as likely to be most impacted by the decision to delay the further easing of restrictions.

1.6 On 30 November 2021, new restrictions came into place to help to prevent the spread of the Omicron variant of Covid-19. Although the restrictions do not apply to hospitality settings, the hospitality sector is reporting that the public health messages are having a significant impact on their businesses.

1.7 The Additional Restrictions Grant guidance instructs councils to use the funding to provide direct support to businesses, either in the form of grants or through wider business support measures. Funding can be transferred to third parties, including Growth Hubs, for the delivery of the support.

2.0 Funding

2.1 The Council's initial 2 allocations of Additional Restrictions Funding from Government totalled £2,925,553. As this funding was fully allocated by 30/7/2021, the Council qualified for top-up funding in the amount of £770,386.

2.2 The remaining funding must be defrayed by 31 March 2022.

3.0 Eligibility criteria and awards for the Additional Restrictions Grant (December 2021 Revision)

3.1 Only businesses in the following sectors will be eligible for an Additional Restrictions Grant (December 2021 Revision):

- Travel Agents
- Tour Operators
- Night Clubs
- Live Music Venues
- Theatres
- Bridal Shops
- Exhibition / Event Organisers
- Exhibition / Event Contractors
- Restaurants
- Public Houses and Bars

Indicative Grant Allocations

3.2 Where a business is shown in the local non-domestic rating list on 20 June 2021, the following grants will be awarded:

Rateable Value	Grant Amount
Up to £15,000	£2,000
Between £15,001 and £51,000	£3,000
£51,001 plus	£4,500

3.3 In addition, where a business is shown in the local non-domestic rating list on 20 June 2021 and was mandated to close between 21/6/21 and 19/7/21, the following grants will be awarded:

Rateable Value	Grant Amount
Up to £15,000	£12,000
Between £15,001 and £51,000	£18,000
£51,001 plus	£27,000

- 3.4 Where a business is not shown in the local non-domestic rating list, a grant of £2,000 will be awarded. The business must provide evidence to show that it was in existence and trading on 20 June 2021.

How will the Additional Restrictions Grant (December 2021 Revision) be provided to businesses?

- 3.5 Businesses that have previously received an Additional Restrictions Grant do not need to submit a new application. They are required to complete a Declaration of Eligibility form which is available on the Wyre Forest District Council website.
- 3.6 Eligible businesses that have not previously received an Additional Restrictions Grant must complete the application form available on the Wyre Forest District Council website.
- 3.7 The application window will close at 5pm on Monday 28 February 2022 or at such time as the funds have been fully allocated.

4.0 Business Support and Post-Lockdown Grants

- 4.1 The primary function of the Additional Restrictions Grant funding is to provide support to businesses during periods of national restrictions. It is anticipated that over £3m worth of grants will have been paid to businesses to fund their fixed costs during periods of restricted trade.
- 4.2 The remaining Additional Restrictions Grant funding will be used to help to drive business recovery. This will take the form of a large capital grant and contributions to County-wide business support schemes.

5.0 Eligibility criteria and awards for the Bounce Back Grant

- 5.1 The Bounce Back Grant is available to businesses in all sectors. The business must have been trading at least 2 years and have a minimum of one employee in addition to the proprietor.
- 5.2 The Bounce Back Grant will cover up to 75% of eligible costs to deliver a project that will drive the business' recovery. Eligible expenditure includes new plant and equipment, improvements to systems and production processes, digital adoption and diversification.
- 5.3 The grant is not retrospective and businesses cannot apply for funding for goods and services that they purchased prior to submitting their grant application. Only expenditure made after the grant application has been approved will be eligible.
- 5.4 Grants of between £5,000 and £30,000 are available. Larger grants will be considered in exceptional circumstances.
- 5.5 The project should safe-guard existing jobs and / or create new ones.

How will the Bounce Back Grant be provided to businesses?

- 5.6 The Bounce Back Grant will be subject to a prior application process. Businesses should request an application form from the North Worcestershire Economic Development & Regeneration Team.
- 5.7 The deadline for submitting an application is 5pm on Monday 31 January 2022. The application window may close earlier if all funding is allocated prior to this date.
- 5.8 If your application is approved, the grant will be paid upon receipt of a completed claims form and evidence of spend. Applicants must be able to cash flow the project.
- 5.9 Completed claim forms for the Bounce Back Grant must be submitted by 18/3/22. Please note that any claim forms submitted after this date will not be paid.

6.0 Business Support Programmes

- 6.1 Additional Restrictions Grant funding will be used to deliver match-funded business support programmes. These programmes provide direct support to businesses to assist them to start-up, grow, innovate and to reduce carbon emissions.
- 6.2 These programmes are administered by Worcestershire County Council and are match-funded by European Regional Development Funds.

7.0 Excluded businesses

- 7.1 The following businesses will **not** be eligible for an award:
 - (a) Businesses which have already received grant payments that equal the maximum levels of subsidy under the Covid-19 Business Grant Allowance (£1,600,000 per economic actor); and
 - (b) Businesses that are in administration, are insolvent or where a striking-off notice has been made.

Definitions

The following definitions are used within this document:

‘Additional Restrictions Grant (ARG)’ means the additional funding provided by Government. Funding was made available to eligible Local Authorities at the point that national restrictions were imposed or at the point the Local Authority first entered LCAL 3 local restrictions;

‘COVID-19’ (coronavirus); means the infectious disease caused by the most recently discovered

‘Department for Business, Energy & Industrial Strategy (BEIS)’; means the Government department responsible for the scheme and guidance;

‘Effective date’; means, for eligibility of the grant, the date of the local restrictions or the date of widespread national restrictions. For the purpose of this scheme the date cannot be before 5/1/21;

‘Hereditament(s); means the assessment defined within Section 64 of the Local Government Finance Act 1988;

‘Local Covid Alert Level’ (LCAL) means the level of alert determined by Government and Local Authorities for the area. LCALs have three Tiers. Tier 1 (Medium): Tier 2 (High) and Tier 3 (Very High). For the purposes of these schemes the definitions used are LCAL1, LCAL2 and LCAL3.

‘Local lockdown’; means the same as **‘Local restrictions’;**

‘Local rating list’; means the list as defined by Section 41 of the Local Government Finance Act 1988

‘Local restrictions’; and **‘Localised restrictions’** means legally binding restrictions imposed on specific Local Authority areas or multiple Local Authority areas, where the Secretary of State for Health and Social Care requires the closure of businesses in a local area under regulations made using powers in Part 2A of the Public Health (Control of Disease) Act 1984 in response to the threat posed by coronavirus and commonly as part of a wider set of measures;

‘Local Restrictions Support Grant Scheme (Closed); means the grant scheme developed by the Council in response to an announcement made by the Secretary of State for Business, Energy & Industrial Strategy made on 9 September 2020 and amended on 9 October 2020 and which is applicable to businesses forced to close under either LCAL3 or where national restrictions are in place;

‘Local Restrictions Support Grant Scheme (Closed) Addendum; means the changes made to the Local Restrictions Support Grant Scheme (Closed) due to widespread nationwide restrictions;

‘Ratepayer’; means the person who, according to the Council’s records, was the ratepayer liable for occupied rates in respect of the hereditament at the date of the local restrictions or widespread national restrictions;

‘State Aid Framework’; means the Temporary Framework for State aid measures to support the economy in the current COVID-19 outbreak published on 19 March 2020; and

‘Temporary Framework for State aid’; means the same as the **‘State Aid Framework’**. Wyre Forest District Council/Additional Restrictions Grants Scheme (ARG) 04112020

1.0 Purpose of the Scheme and background

1.1 The purpose of this document is to determine eligibility for a payment under the Council’s Additional Restrictions Grant Scheme from 5 January 2021. The Council, as the Business Rates Billing Authority is responsible for payment of these grants.

1.2 This discretionary grant scheme has been developed by the Council in response to an announcement made by the Secretary of State for Business, Energy & Industrial Strategy on 31 October 2020, which sets out the basic circumstances whereby an additional restriction grant payment may be made by the Council to a business which has to close or is severely affected due to localised or widespread national restrictions being put in place to manage coronavirus and save lives.

1.3 Whilst the awarding of grants will largely be at the Council’s discretion, the Department for Business, Energy & Industrial Strategy (BEIS) has set down criteria which **must** be met by each business making an application.

1.4 The scheme applies where local restrictions (LCAL3) are put in place **or** where a widespread national lockdown is announced.

1.5 Localised restrictions are legally binding restrictions imposed on specific Local Authority areas or multiple Local Authority areas, where the Secretary of State for Health and Social Care requires the closure of businesses in a local area under regulations made using powers in Part 2A of the Public Health (Control of Disease) Act 1984 in response to the threat posed by coronavirus and commonly as part of a wider set of measures.

1.6 National restrictions are nationally binding widespread restrictions imposed by Parliament under legislation. The current national restrictions are made under the Health Protection (Coronavirus, Restrictions) (England) (No. 4) Regulations 2020.

1.7 Grants under this scheme will be available for the 2020/21 and 2021/22 financial years only.

1.8 No grant shall be paid for any period where the localised or widespread national restrictions were in place prior to 14 October 2020.

1.9 Where any area enters either a localised restriction (LCAL3) or where a national restriction applies, additional assistance may be given to businesses under the Council’s Local Restrictions Support Grants (Closed) Scheme (as amended).

2.0 Funding

2.1 Under the Additional Restrictions Grant Scheme (ARG) provisions, Local Authorities will receive a one-off lump sum payment amounting to £20 per head in each area when local restrictions (LCAL3) or widespread national restrictions are imposed. In addition, a further £899,733 was awarded in January 2021 resulting in a total budget of £2,925,553.

2.2 If the Council distributes its full allocation by 30/6/2021, it will receive a further allocation of funding in the amount of £770,386. Further top-up funding may be allocated at the Government's discretion.

3.0 Eligibility criteria and awards

3.1 The Council is able to use this funding for business support activities and the Government envisages that this will primarily take the form of discretionary grants although it can be used for wider business support activities.

In its guidance dated 4/3/2021, Government authorised Local Authorities to provide additional support to larger local businesses which are important to the local economy. This support can be in addition to any funding provided by other schemes but with due reference to subsidy allowance conditions.3.3 Government has stated that the Council *may* also consider making grant payments to those businesses which, while not legally forced to close are nonetheless severely impacted by the restrictions put in place to control the spread of Covid-19. Government has also stated that the Council may also wish to assist business which are outside of the rating system and which are effectively forced to close.

3.4 Local Authorities are also encouraged to support businesses from all sectors that have been significantly impacted by the restrictions in place but are not eligible for the Restart Grant Scheme.

3.5 The Council has decided that the Additional Restrictions Grant allocation will be used to fund three schemes :

- the Additional Restrictions Grant 2021 covering the period 5/1/21 to 31/3/21;
- the Recovery grant, a one off payment to businesses in receipt of the Additional Restrictions Grant 2021 to assist them to return to normal trading; and
- the Strategic Businesses grant, for large employers and key tourism assets.

Additional Restrictions Grant

Proposed Eligible Businesses and Indicative Grant Allocations

3.6 Where a business is shown in the local non-domestic rating list, the following grants will be awarded:

Rateable Value	Grant Amount
Up to £15,000	£4,097
Between £15,001 and £51,000	£6,143
£51,001 plus	£9,214

3.7 Where a business is not shown in the local non-domestic rating list, the following grants will be awarded:

Eligible businesses	Amount
Market Trader regularly trading on a market in Wyre Forest	£66.70 for each day's worth of normal market activity in Wyre Forest during the 12 week period, subject to a maximum payment of £4,097
Bed & Breakfast that pays Council Tax rather than business rates	£4,097
Businesses in shared spaced that have been forced to close	£4,097
Businesses that provide mobile personal care services that are required to close	£4,097
Business that trade under a street trading licence	£4,097
Any other eligible business	£4,097

Eligibility Criteria

3.8 Any business can apply; however, the following will be considered as priority:

- Businesses that supply goods and services to businesses in the retail, hospitality and leisure sectors;
- Businesses that supply goods and services to the events sector;
- Businesses that have fixed property costs but do not have a separate listing on the business rates system, e.g. Market Traders, Street Licence Holders, Businesses in Shared Spaces;
- Businesses that provide mobile personal care services that are required to close;
- Businesses that, whilst not required to close, have been significantly impacted by the restrictions in place.

3.9 All applicants will be required to demonstrate that they have been significantly impacted by the restrictions in place.

3.10 Businesses that have been mandated to close and are eligible for the Local Restrictions Support Grant (Closed Addendum) are not eligible for the Additional Restrictions Grant.

Recovery Grant

Proposed Eligible Businesses and Indicative Allocations

3.11 Where a business is shown in the local non-domestic rating list, the following grants will be awarded:

3.12 Where a business is not shown in the local non-domestic rating list, the following grants will be awarded:

Eligible businesses	Amount
Market Trader regularly trading on a market in Wyre Forest	£400 for each regular trading day in a week in Wyre Forest, subject to a maximum payment of £2,000
Bed & Breakfast that pays Council Tax rather than business rates	£2,000
Businesses in shared spaced that have been forced to close	£2,000
Businesses that provide mobile personal care services that are required to close	£2,000
Business that trade under a street trading licence	£2,000
Any other eligible business	£2,000

Eligibility Criteria

3.13 To be eligible for a Recovery Grant, businesses must have received an Additional Restrictions Grant 2021. The Additional Restrictions Grant is currently open to new applications.

3.14 Businesses that are eligible for the Restart Grant **are not** eligible for the Recovery Grant.

Strategic Business Grant

3.15 Officers will work with the local Growth Hubs to identify strategic businesses and key arts and tourism assets. Eligibility criteria will include number of employees and impact on the local economy. The businesses will be invited to apply for a Strategic Business Grant.

3.16 Grant amounts will be based upon available funding but will be a minimum £50,000 per business.

Excluded businesses – All Grants

3.17 The following businesses will **not** be eligible for an award:

- (a) Businesses in areas outside the scope of the localised restrictions, as defined by Government and not subject to a widespread national restriction;
- (b) Businesses that have chosen to close but not been required to, will not be eligible;
- (c) Businesses which have already received grant payments that equal the maximum levels of subsidy under the Covid-19 Business Grant Allowance (£1,600,000 per economic actor) ; and
- (d) Businesses that were in administration, are insolvent or where a striking-off notice has been made at the date of the local restriction or widespread national restriction.

The Effective Date

3.18 The effective date for eligibility is the date of the widespread national or local restrictions (LCAL3). Businesses **must** have been trading on the first full day of national or LCAL3 restrictions to be eligible to receive grant support.

Who can receive the grant?

3.19 In **all** cases, Government has stated that the person who will receive the grant will be the person who, according to the Council's records, was the ratepayer in respect of the hereditament at the effective date.

3.20 Where the Council has reason to believe that the information it holds about the ratepayer at the effective date is inaccurate, it may withhold or recover the grant and take reasonable steps to identify the correct ratepayer.

3.21 Where, it is subsequently determined that the records held are incorrect, the Council reserves the right to recover any grant incorrectly paid.

3.22 Where any business misrepresents information or contrives to take advantage of the scheme, the Council will look to recover any grant paid and take appropriate legal action. Likewise, if any ratepayer is found to have falsified records in order to obtain a grant.

3.23 Where there is no entry in the rating list for the business, the Council will have discretion to determine who should receive the grant.

4.0 How will grants be provided to businesses?

4.1 The Council is fully aware of the importance of these grants to assist businesses and support the local community and economy. The Council's Additional Restrictions Grant (ARG) scheme together with the Local Restrictions Support Grant (Closed) will offer a lifeline to businesses who are struggling to survive during to the COVID-19 crisis.

4.3 Where a business has previously received an Additional Restrictions Grant for the period 5/11/20 to 2/12/20 and / or Local Restrictions Support Grant (Open), they will automatically be considered for an Additional Restrictions Grant (2021).

4.4 In all cases, businesses will be required to confirm that they are eligible to receive the grants. This includes circumstances where the Council already has bank details for the business and are in a position to send out funding immediately. Businesses are under an obligation to notify the Council should they no longer meet the eligibility criteria for any additional grants.

4.5 The Council reserves the right request any supplementary information from businesses, and they should look to provide this, where requested, as soon as possible.

4.6 An application for an Additional Restriction Grant is deemed to have been made when a duly completed application form is received via the Council's online procedure.

4.7 All monies paid under this scheme will be funded by Government and paid to the Council under S31 of the Local Government Act 2003.

5.0 State Aid

Any grant is given as aid in accordance with the Small Amounts of Financial Assistance Allowance (Article 3.2(4) of the Trade and Co-operation Agreement), which enables an applicant to receive up to £335,000 over any period of three fiscal years. Where the Small Amounts of Financial Assistance Allowance has been reached, grants may be paid in compliance with the Trade and Co-operation Agreement under the COVID-19 Business Grant Allowance (subsidies granted on a temporary basis to respond to a national or global economic emergency). For the purposes of these scheme rules, this allowance is £1,600,000 per single economic actor. This allowance includes any grants previously received under the COVID-19 business grant schemes and any State aid previously received under Section 3.1 of the European Commission's Temporary Framework across any other UK scheme. This may be combined with the Small Amounts of Financial Assistance Allowance to equal £1,935,000.

6.0 Scheme of Delegation

6.1 The Council has approved this scheme.

6.2 Officers of the Council will administer the scheme and the Section 151 Officer is authorised to make technical scheme amendments to ensure it meets the criteria set by the Council and, in line with Government guidance.

7.0 Notification of Decisions

7.1 Applications will be considered on behalf of the Council by the North Worcestershire Economic Development and Regeneration service.

7.2 All decisions made by the Council shall be notified to the applicant either in writing or by email. A decision shall be made as soon as practicable after an application is received.

8.0 Reviews of Decisions

8.1 The Council will operate an internal review process and will accept an applicant's request for a review of its decision.

8.2 All such requests must be made in writing to the Council within 14 days of the Council's decision and should state the reasons why the applicant is aggrieved with the decision of the Council. New information may be submitted at this stage to support the applicant's appeal.

8.3 The application will be reconsidered by a senior officer, as soon as practicable and the applicant informed in writing or by email of the decision.

9.0 Complaints

9.1 The Council's 'Complaints Procedure' (available on the Council's website) will be applied in the event of any complaint received about this scheme.

10.0 Taxation and the provision of information to Her Majesty's Revenues and Customs (HMRC)

10.1 The Council has been informed by Government that all payments under the scheme are taxable.

10.2 The Council does not accept any responsibility in relation to an applicant's tax liabilities and all applicants should make their own enquiries to establish any tax position.

10.3 All applicants should note that the Council is required to inform Her Majesty's Revenue and Customs (HMRC) of all payments made to businesses.

11.0 Managing the risk of fraud

11.1 Neither the Council nor Government will accept deliberate manipulation of the schemes or fraud. Any applicant caught falsifying information to gain grant money or failing to declare entitlement to any of the specified grants will face prosecution and any funding issued will be recovered from them.

11.2 Applicants should note that, where a grant is paid by the Council, details of each individual grant may be passed to Government.

12.0 Recovery of amounts incorrectly paid

12.1 If it is established that **any** award has been made incorrectly due to error, misrepresentation or incorrect information provided to the Council by an applicant or their representative(s), the Council will look to recover the amount in full.

13.0 Data Protection and use of data

13.1 All information and data provided by applicants shall be dealt with in accordance with the Council's Data Protection policy and Privacy Notices which are available on the Council's website.
