#### LIC.09 Apologies for Absence

There were no apologies for absence.

#### LIC.10 Appointment of Substitutes

No substitutes were appointed.

#### LIC.11 Declaration of Interests

As recorded later in the minutes, Councillor F Oborski MBE declared in respect of exempt agenda item no. 8 – Review of a Hackney Carriage / Private Hire Driver's Licence, that the applicant may be a member of her political party but she had not met him at meetings. She said that she may have been in his taxi as she has used most of the taxis across the district.

## LIC.12 Minutes

Decision: The minutes of the meeting held on 6 June 2022 be confirmed as a correct record and signed by the Chairman.

#### LIC.13 Licensing Committee and the role of Licensing Sub-committees

As requested by members, the Committee received a report from the Head of Worcestershire Regulatory Services to enable them to consider whether the Council should continue the use of Licensing Sub-committees to consider applications.

The Principal Officer – Licensing, presented the report and outlined the key issues. He explained that any proposed amendment to the Council's Constitution, in relation to ceasing to operate Licensing Sub-committees and referring general licensing applications to the full Licensing and Environmental Committee for consideration and determination, may lead to the Council being in a position where it would be unable to fulfil its legal responsibilities under the

Licensing Act 2003 and the Gambling Act 2005.

He added that it was Officers' strong professional advice that members should not recommend altering the Council's current decision making structure in relation to licensing and gambling applications and the referral to Licensing Sub-committees for consideration and determination.

The Committee discussed the report. Several members expressed concern that members are currently excluded from sitting on a Sub-committee if the application is in their respective ward. Members felt that in order to fully represent their wards, they should be able to participate.

Decision: The Committee noted the content of the report and agreed to operate under the Council's current Constitution in respect of licensing functions, in relation to the Licensing and Environmental Committee and Licensing Sub-committees.

Moving forward, when arranging a Licensing Sub-committee, all members, whether a member in the Ward or not, could be invited to the Sub-committee. However, the member would need to ensure they do not have any reasons why they could not openly and transparently take part in such a meeting. If the member has any doubt, at the earliest opportunity they must ensure they take the relevant legal advice and advise Committee Services at their earliest opportunity if they are unable to take part in the Sub-committee.

#### LIC.14 Exclusion of the Press and Public

Decision: Under Section 100A(4) of the Local Government Act, 1972 the press and public be excluded from the meeting during consideration of the following items of business on the grounds that they involve the likely disclosure of "Exempt Information" as defined in paragraphs 7 of Part I of Schedule 12A of the Act.

#### LIC.15 Review of a Hackney Carriage / Private Hire Driver's Licence

The Committee received a report from the Head of Worcestershire Regulatory Services that asked member to consider and determine whether a licence holder remained a fit and proper person to hold a licence to drive hackney carriage and private hire vehicles.

The Chairman welcomed the applicant and his legal representative to the meeting. The applicant's legal representative confirmed that the applicant had received and understood the procedure note for the hearing.

Councillor F Oborski MBE made her declaration at this point.

A copy of the applicant's Disclosure and Barring Service (DBS) certificate and a personal statement from the applicant was circulated to members.

The Principal Officer – Licensing, presented the report and outlined the key issues. He advised members that the Hackney Carriage and Private Hire

#### Agenda Item No. 4

Policy Standard conditions attached to a licence to drive a hackney carriage and / or private hire vehicles states that a licence holder must notify the licencing authority as soon as reasonably practicable and within no more than 48 hours if they receive a conviction, caution or fixed penalty in relation to any offence. He added that at the time of the applicant's caution, the notification period was within 7 days.

The applicant's legal representative addressed the Committee. She read out a personal statement on behalf of the applicant. Following questions from members the applicant's legal representative explained the circumstances surrounding the offence.

The Principal Officer – Licensing, applicant and his legal representative left the meeting at this point, (11.44am) for members to deliberate their decision. The Solicitor and the Principal Committee and Member Services Officer stayed in the meeting whilst the Committee reached their decision.

The Principal Officer – Licensing, applicant and his legal representative re-entered the meeting at 12.18pm. The Solicitor read out the decision of the Committee.

Decision: Having reviewed the applicant's Hackney Carriage/Private Hire Driver's Licence and carefully considered whether the applicant is a fit and proper person to continue to hold such a licence, the Committee have decided, with due consideration of the Hackney Carriage and Private Hire Licensing Policy and the 'Guidelines on the Assessment of Previous Convictions' contained therein:

That notwithstanding the applicant's caution for battery which was issued to him by West Mercia Police on 8 October 2020 and his failure to declare his caution on his renewal application and the Guidelines on the Assessment of Previous Convictions, they are satisfied, that the applicant is a "fit and proper person" to continue to hold a Hackney Carriage/Private Hire Driver's Licence and they are justified in departing from the Council's Guidelines on the Assessment of Previous Convictions because of the exceptional circumstances presented to the Committee that:

- 1. The applicant has no previous convictions or cautions, and this is his first offence. There were no complaints received against him in the 10 years he has been a taxi driver.
- 2. The circumstances of the offence that were explained to the committee during the hearing by the applicant's representative do not indicate that the applicant is a danger to the travelling community as the circumstances arose from the applicant's desire to protect the public in the circumstances of Covid 19 restrictions.
- 3. The applicant remains a respected member of his worshipping community.
- 4. The applicant admitted the offence during the investigation, as a

result of which the matter was dealt with through the issue of a simple caution, rather than the more serious criminal proceedings in the court.

5. The applicant was given the opportunity to declare his previous convictions on the licence application and he accepts that he should have declared his caution.

Whilst the committee considers that the applicant remains a "fit and proper person" the committee also considers that given the circumstances and the applicant's standing in the community a verbal warning is appropriate and a reminder that should a further incident of violence occur the matter would have to come back to the committee.

The meeting ended at 12.21pm.

#### 1. <u>PURPOSE OF REPORT</u>

1.1 To inform Members of the recent review of the Council's Licensing and Regulatory Services Function fees and charges for the financial year 2023/24.

#### 2. <u>RECOMMENDATION</u>

The Committee is asked to:

- 2.1 Note the contents of this report, in particular the draft Licensing & Environmental Health fees and charges for 2023/24 at Appendix 1, and
- 2.2 Resolves to recommend to Council that the proposals for fees and charges within the Council's Licensing, Food, Health, Safety and Pollution Control functions for 2023/24, as detailed in the report, be included in the Council's 2023/24 budget strategy.

#### 3. BACKGROUND

- 3.1 As part of the legal agreement established with the formation of Worcestershire Regulatory Services, licensing remains a reserved matter. As a reserved matter all policy decisions, as well as income and fee setting remain the responsibility of the council.
- 3.2 It is the role of the council to review and set its licensing fees and charges on an annual basis. Worcestershire Regulatory Services Licensing and Support Services Manager works closely with the Chief Executive, and the council's Finance Officers in establishing accurate details, regarding working towards the full cost recovery of the licensing service in relation to the relevant Cost Centres.

- 3.3 This annual review of licensing fees and charges has now taken place by the Licensing Manager and senior Council Officers. A copy of the proposed Licensing & Environmental Health fees and charges for 2023/24 is attached at "**Appendix 1**".
- 3.4 The Council's current financial strategy in respect of the Council's Licensing and Regulatory Services fees and charges is generally to increase them by 5%.

## 4. <u>KEY ISSUES</u>

- 4.1 A review of licensing fees and charges, for the period 2020/21, has resulted in a fee structure based on full recovery of costs.
- 4.2 Members should note that Alcohol and Entertainment (Licensing Act 2003) licensing fees are set nationally by Central Government and therefore are not under the control of the Licensing and Environment Committee.
- 4.3 Ideally taxi licensing fees and charges should remain broadly cost neutral. However fees in Wyre Forest have been higher than in surrounding areas for many years, and any differences have been exacerbated when the Council has increased its fees in line with the corporate policy of generally increasing fees by 5% a year, when some other councils may have chosen to freeze fees or implement lower increases. Private hire vehicles can trade anywhere and there has been evidence of some vehicles/drivers switching to being licensed by other neighbouring or nearby authorities. Likewise, hackney carriages can take booked work anywhere but cannot ply for trade in the district unless they have a Wyre Forest plate.
- 4.4 The Licensing Committee is invited to consider a radical realignment of vehicle and driver licensing fees but that this should involve discussion with the licensed trade about a package of reform, that would address other concerns about aspects of licensing policy in Wyre Forest and the need to see positive progress in moving towards a fleet that is not dependent on fossil fuels. The latter would be consistent with the Council's declaration of a climate change emergency in 2019.

- 4.6 The proposed changes to the structure of licence fees should be accompanied by a programme of reform. This will include:
  - Work with the licensed trade to be concluded by September 2023 in order to identify a date after which no more fossil fuel vehicles will <u>enter</u> the fleet, such date to be no later than 2027 and preferably sooner. This will not affect the ability of vehicles licensed before the cut-off date to continue within the fleet, so long as other requirements of the licensing policy (such as condition of the vehicle etc) continue to be met
  - Review of policy on vehicle colours (either wider range of colours or dropping requirements altogether) and maximum age of vehicle on first licensing (currently 2 years, with possibility of extension to 3 years).

A report will be brought back to a future meeting of the Committee to agree changes to the licensing policy as part of this programme of reform.

- 4.7 The structure of taxi and private hire vehicle fees will be subject to review after 12 months in terms of the impact on the total number of licences in issue, the ability to make progress on the programme of reform and the Council's financial position in light of Government funding decisions.
- 4.8 All other licensing functions such as gambling, street trading, street amenity and scrap metal licensing should remain cost neutral and the proposed fees reflect this from the financial details of the income generated.

## 5. FINANCIAL IMPLICATIONS

5.1 With the exception of statutory fees (which include the Licensing Act 2003 applications and certain Gambling Act 2005 applications) set by Central

Government and taxi licensing fees and charges, it is proposed that all fees should be increased by between 5% rounded up, where appropriate. A list of the proposed fees and charges for the Council's Licensing, Food, Health, Safety and Pollution Control functions is attached at **"Appendix 1".** 

- 5.2 The budget forecast details the cost versus income for licensing and the costs are based on 2020/2021, as no detailed figures are available for the current financial year.
- 5.3 The budget forecast for 2020/21 excluding those statutory fees which are set by Central Government, show that no projected surplus will be made in respect of the activities whose fees have been increased in the list of proposed fees and charges attached at **"Appendix 1"**.
- 5.4 Significant reductions to taxi and private hire vehicle fees would have financial implications for the Council, as the proposals would reduce income generated by Worcestershire Regulatory Services and would have to be made good by WFDC. Based on current licence numbers, and assuming a modest number of vehicles/drivers currently licensed by other authorities return to being licensed by WFDC, the full year impact is estimated at £35k. Provision for this impact would need to be made in the Council's medium term financial strategy for 2023-2026.

#### 6. LEGAL AND POLICY IMPLICATIONS

- 6.1 The agreed income to be generated by the proposed licence fees and charges is in line with the current policy and legislative restrictions. The Council is not projected to make any surplus on the licensing activities for which the proposed fees are being increased for the forthcoming year.
- 6.2 The Council is required by section 70 of the Local Government (Miscellaneous Provisions) Act 1976, to advertise any proposed variation to its fees for hackney carriage and private hire vehicle and operator licences by publishing a notice in a local newspaper. This notice must provide a period of not less than 28 days for people to raise objections to the proposed variations to the fees.
- 6.3 A copy of this notice must also be deposited at the offices of the council for a period of twenty-eight days from the date of the first publication and must be available for public inspection at all reasonable hours without payment.

#### 7. <u>RISK MANAGEMENT</u>

7.1 There is a risk that the Council's Regulatory Services Licensing fees and charges could be challenged. To minimise this risk the fees and charges must be designed to meet, but not exceed the cost the Council reasonably believes will be incurred in issuing of licences and the administration of the service.

#### 8. EQUALITY IMPACT ASSESSMENT

8.1 There are no equality impact assessment issues arising from this report.

## 9. <u>CONCLUSION</u>

9.1 The fees and charges are non-profit making and Cost Centres will reflect the operation of the service.
