#### **Disclosure of Interests**

Members and co-opted Members of the Council are reminded that, in accordance with the Council's Code of Conduct and the statutory provisions of the Localism Act, they are required to consider in ADVANCE of each meeting whether they have a disclosable pecuniary interest (DPI), an other registrable interest (ORI) or a non-registrable interest (NRI) in relation to any matter on the agenda. If advice is needed, Members should contact the Monitoring Officer or other legal officer in good time before the meeting.

If any Member or co-opted Member of the Council identifies a DPI or ORI which they have not already registered on the Council's register of interests or which requires updating, they should complete the disclosure form which can be obtained from Democratic Services at any time, copies of which will be available at the meeting for return to the Monitoring Officer.

Members and co-opted Members are required to disclose any DPIs and ORIs at the meeting. Where the matter relates to a DPI they may not participate in any discussion or vote on the matter and must not stay in the meeting unless granted a dispensation.

Where the matter relates to an ORI they may not vote on the matter unless granted an advance dispensation.

Where a Member or co-opted Member has an NRI which directly relates to their financial interest or wellbeing, or that of a relative or close associate, they must disclose the interest at the meeting, may not take part in any discussion or vote on the matter and must not stay in the meeting unless granted a dispensation.

Where a matter affects the NRI of a Member or co-opted Member, the Code of Conduct sets out the test which must be applied by the MEMBER to decide whether disclosure is required. Again please ensure you have spoken in ADVANCE to the relevant legal officer and determined whether it is appropriate to declare the NRI and leave.

Councillor C Rogers was nominated as Chairman. This was moved by Councillor M Hart and seconded by Councillor T Onslow.

Decision: Councillor C Rogers be elected as Chairman of the Council for the municipal year 2023-2024.

#### C.03 Chairman – Investiture and Declaration of Acceptance of Office

After being invested with his Chain of Office, Councillor C Rogers made his Declaration of Acceptance of Office as Chairman.

#### C.04 Chairman's Response

The Chairman thanked members for his appointment. He said it was a great honour to be in the position and would do his best to help everybody. He announced that his chosen charity for the municipal year was Midlands Air Ambulance.

#### C.05 Retiring Chairman

On behalf of the political groups Conservative Group, Councillor M Hart, Independent and Green Group, Councillor M Rayner, Labour Group, Councillor L Whitehouse and Liberal Democrat Group, Councillor F Oborski MBE, thanked the retiring Chairman for his contribution to the role during his term of office.

#### C.06 Election of Vice-Chairman

Councillor P Harrison nominated Councillor J Byng as Vice-Chairman. This was seconded by Councillor I Hardiman.

Decision: Councillor J Byng be elected as Vice-Chairman of the Council for the municipal year 2023-2024.

## C.07 Vice-Chairman – Investiture and Declaration of Acceptance of Office

After being invested with his Badge of Office, Councillor J Byng made his Declaration of Acceptance of Office.

#### C.08 Election of Leader of the Council

Council considered a report from the Chief Executive which asked members to elect a Leader of the Council for the period to the annual general meeting following the ordinary elections in 2027, in accordance with section 9I of the Local Government Act 2000 and the Council's constitution.

Councillor I Hardiman proposed Councillor M Hart for the position of Leader of the Council. The proposal was seconded by Councillor D Ross.

There were no other nominations and following a unanimous vote Councillor M Hart was elected as Leader of the Council.

Decision: Council elected Councillor M Hart as the Leader of the Council for the period to the annual general meeting of the Council following the next ordinary elections in May 2027.

He confirmed the appointment of Councillor Kevin Gale and Councillor Alan Sutton as Armed Forces Champions and also announced the members whom he had appointed to serve with him in the Cabinet.

#### 1. <u>PURPOSE OF THE REPORT</u>

1.1 To provide a report on the local elections held on 4<sup>th</sup> May 2023

#### 2. <u>RECOMMENDATIONS</u>

The Council is asked to

2.1 NOTE the report on the May 2023 elections.

#### 3. ELECTION BACKGROUND

3.1 All out elections were held in Wyre Forest District on Thursday 4<sup>th</sup> May 2023 for Wyre Forest District Council (12 wards with a total of 33 seats to elect). In addition there were contested elections for both Stourport-on-Severn Town Council (4 of the 6 Town wards with a total of 10 seats) and Bewdley Town Council (3 Town wards with a total of 13 seats). Stourport-on-Severn North and Stour and Wilden wards of Stourport-on-Severn Town Council did not have contested elections, the first time that elections to a town council have not been contested in well over a decade. The Parish councils of Broome (7 seats), Chaddesley Corbett (11), Churchill & Blakedown (9), Kidderminster Foreign (7), Rock (13), Rushock (7), Stone (9), Upper Arley (9) and Wolverley & Cookley (14), also held all out elections.

- 3.2 Following the implementation of the Elections Act 2022 the local elections were the first in England to require voters to show a form of photo identification before being issued with a ballot paper. Voters could use a wide range of ID such as passports, full and provisional driving licences, Proof of Age Standards Scheme (PASS) cards, blue badges, and some concessionary travel cards. The ID used in a polling station must be original, but it did not matter if it was expired so long as the photo was a good likeness. Voters without an existing acceptable form of photo ID could apply for a free Voter Authority Certificate (VAC). The VAC displayed a voter's name and a passport style photo. Provision was also made at every polling station to allow voters to request that their ID was inspected in private.
- 3.3 In Wyre Forest 210 applications were received by the deadline for voter authority certificates, and 195 were issued for applicants who had provided all necessary information including a satisfactory photograph. One temporary VAC was issued. In total, 36% of VACs were used which means that those holding a VAC were more likely to vote in person than the generality of electors.
- 3.4 There was a very high compliance rate among electors in Wyre Forest. 99.8% of 12,200 electors voting in polling stations brought photo ID that met the requirements of the Elections Act 2022. By the end of the polling day, 22 electors who tried to vote in a polling station were not given a ballot paper because they did not meet the new voter ID requirements. This represents only 0.2% of electors who asked to be issued with a ballot paper in a polling station. The figures also show that, while 32 electors were initially turned away, ten returned with acceptable ID and were able to vote.

#### 4. <u>NOMINATIONS</u>

- 4.1 There was a total of 99 nominations received for the district council election which was slightly down on the 102 received for the all-out district elections held in 2019.
- 4.2 There were 128 nominations received for the Town and Parish Councils which resulted in all the wards for Bewdley Town Council and four of the six Stourporton-Severn Town Council wards being contested. Polls were held in Stourport-on-Severn Areley Kings East, Stourport-on-Severn Areley Kings West, Stourport-on-Severn Central and Stourport-on-Severn Lickhill. For all other parish councils, the candidates were duly elected as the number of candidates was the same as or lower than the number of vacancies and therefore no poll was held.

#### 5. <u>TURNOUT</u>

- 5.1 The overall turnout for each of the elections held on 4 May 2023 was as follows
  - Wyre Forest District Council 28%. The count was held on 5 May 2023 and the last seat was declared at 16:40

- Bewdley Town Council 34.4% with the last seat declared at 17:30
- Stourport Town Council- 28.4% with the last seat declared at 16:55
- 5.2 For comparison purposes a breakdown of the overall turnout figures for various elections may be found in Appendix 1. The appendix also gives detailed analysis of postal votes, invalid postal votes, and unused votes.
- 5.3 The trend of postal voters being far more likely to cast their vote than people voting in person has become well established. Therefore, while other measures to encourage participation will continue, the most effective is likely to be encouraging more people to register for a postal vote. The correct information about turnout by postal voters may be seen in tables 4 to 6. Participation was in line with previous elections, reaching more than 70% in each type of election. (Earlier announcements, including those at the count, unfortunately did not use the correct divisor and therefore understated the percentage of postal voters who had voted. I apologise for that error, which did not affect the result of the elections.)

#### 6. FEEDBACK FROM THE DEBRIEFING MEETING

- 6.1 A 'wash-up' de-brief was held with agents and candidates on 25 May to discuss the preparation and delivery of the local elections in May 2023. This meeting was attended by several sitting members and agents representing several political parties. The main discussion included:
- Concern about the design and change of the poll card that now is an A4 Poll Card letter rather than the traditional A5 postcard-size. Parties were reminded that the change to the Poll Card letter was introduced as a direct consequence of the Elections Act 2022, which requires far more information to be on the Poll Card a sample of the letter issued is shown in appendix 2 together with the prescribed wording that must be included. The design of the Poll Card letter is now being reviewed for use in future polls to ensure that the "traditional" poll card element is prominently located at the top of the letter and, if possible, that a map of where the polling station is located is included;
- Representatives of the parties reported a number of cases of electors claiming not to have received Poll Cards, and similar feedback was received at some polling stations. There is no evidence to suggest that the letters were not issued. The likeliest explanation is that the letters were either not opened or that electors did not realise that the letter was the Poll Card despite the clear wording of the letter and the wording on the outside of the envelope, a sample of which is in Appendix 2. The move from A5 style cards to A4 letters may have meant that some people did not retain the document as they would have done in the past. There is no requirement for an elector to produce the Poll Card letter in order to vote;
- Difficulties were experienced by some voters in finding the BHS-5 polling station which is now at Habberley Social Club, following the polling places review approved by Council on 7<sup>th</sup> December 2022. It is apparent that some electors did not seek to check the location on a paper map, on line or using satellite navigation

prior to setting out on their journey to the polling station. Additional A-board and other signage was deployed several times during the day to assist in showing the route from Canterbury Avenue: regrettably this was removed or turned around on a number of occasions by unhelpful members of the public. As noted above, consideration is being given to including a map on all Poll Card letters in future;

- Arrangements at Trinity Methodist church to accommodate a third polling station in a large room worked well but, for the much higher turnout expected at a General Election, a second room will be needed to accommodate one of the polling stations;
- The usual room was not allocated at St Anne's Primary School and, while the alternative school hall was larger, it involved a flight of steps or significant ramped path for electors, which was not suitable. Future use of this school will require access to the room that has previously been allocated for elections. Disruption was experienced by the use of the other part of Habberley Social Club and its bar in the evening. Future bookings at this venue will be negotiated on the basis of requiring use of the whole building;
- There were no issues reported in respect of queuing at polling stations and the introduction of an extra poll clerk regarding Voter ID operated successfully;
- A suggestion, that more durable laminated signage should be used, will be considered;
- At double and triple polling stations, few poll card letters were printed with colour coding which made voting at such stations more confusing. This was acknowledged and the process of checking colour coding with the printers would be reviewed.

#### 7. ABSENT VOTING

7.1 Table A below shows the number of postal votes issued and returned including the number of rejected postal votes for the election in May 2023 compared to previous elections.

- 7.2 20 postal packs were received in the post in the 24 hours after the close of poll and a total of 41 have been received in the post since 5<sup>th</sup> May 2023.
- 7.3 The decrease in postal voters from the previous election in 2021 was to be expected as voters changed back to in person voting following the Covid-19 Pandemic.
- 7.4 However the significant increase in postal voters from the previous local government election as well as the general election held in 2019 may have been caused by the need to show photographic ID at a polling station for the first time.
- 7.5 By law the Electoral Registration Officer must write to postal voters whose ballot papers were not included in the count because their personal identifiers on the postal vote could not be verified and to explain the reason why e.g. incorrect date of birth provided or signature didn't match that on their original application form. A total of 104 letters have been issued to those electors who had a postal vote rejected in May 2023. Those whose signature did not match the original supplied will also be sent an identifier refresher form to complete.
- 7.6 The number of proxies appointed at these elections was 45. A breakdown of proxy voters compared to previous elections is set out in Table B.

7.7 The number of proxy voters has increased slightly from the previous major election in 2021 as well as the comparable previous local elections in 2019.

#### 8. <u>COUNT AND RESULTS</u>

8.1 The verification of all ballot boxes and the count for the Wyre Forest District and the contested wards of Bewdley and Stourport Town Council elections took place on 5<sup>th</sup> May 2023, at Wyre Forest Leisure Centre. Information on rejected ballot

papers, including unused votes in multi-member wards, is set out in Tables 8 to Table 13.

#### 9. FINANCIAL IMPLICATIONS

The financial accounts for the different elections held in May 2023 are currently being complied so the appropriate recharges can be made to Bewdley Town Council, Stourport-on-Severn Town Council and all other parish councils who had elections. The balance of costs will be met by WFDC and is expected to fall within the allocated budget for the elections service. The Government provided new burdens funding related to changes introduced by the Elections Act 2022, which will be deployed as relevant in meeting the cost of the elections.

#### 10. EQUALITY IMPACT NEEDS ASSESSMENT

10.1 There are no equalities implications arising from this report. However, all elections and electoral registration activity has due regard to the public sector equality duty in section 149 of the Equality Act 2010.

#### 11. RISK MANAGEMENT

11.1 All elections and electoral registration work is supported by robust risk management plans to ensure contingency arrangements are always in place for meeting electoral legislation.

#### **Rejected ballot papers**

At the count on 5 May 2023 the following number of ballot papers was rejected for each election:

- Wyre Forest District Council- 105 ballot papers were rejected across all wards with 4 for 'want of an official mark', 33 for 'voting for more Candidates than voter was entitled to', 6 'writing or mark by which the voter could be identified' and 62 'unmarked or wholly void for uncertainty'.
- Bewdley Town Council- a total of 27 ballot papers were rejected with 5 being 'voting for more Candidates than voter was entitled to' and 22 for being 'unmarked or wholly void for uncertainty'
- Stourport-on-Severn Town Council- A total of 27 ballot papers were rejected with 1 being 'voting for more Candidates than voter was entitled to', 1 'writing or mark by which the voter could be identified' and 12 'unmarked or wholly void for uncertainty'

The number of unused votes ran well into three or even four figures in each area, reflecting those hundreds of electors who withheld their second and/or third vote. The proportion of electors who withheld their votes varied greatly between wards. The lower proportions were seen in wards where more than one party had fielded full slates of candidates – in such areas supporters of that party were able to use both or all three of their votes to support the same party but, in other areas, party supporters were perhaps naturally less willing to use their second and/or third vote to support other candidates.


